
The Minnesota Municipal Board has now processed and approved the above ordinance in accordance with Minnesota Statutes, Chapter 414, and the Rules of Procedure.



ORDINANCE 85-17

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF FARIBAULT TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS

WHEREAS, a certain petition dated September 5, 1985, requesting annexation of the territory hereinafter described was duly presented to the council on the 24th day of September, 1985; and

WHEREAS, the petition was signed by all owners; and

WHEREAS, no objections to the annexation have been received from the town board at the time of passage, or the governing body of any municipality whose boundaries abut upon the boundaries of the land to be annexed; and

WHEREAS, a hearing was duly held by the governing body of the City of Faribault, Minnesota, on the proposed annexation after mailed notice; and

WHEREAS, the land described in the petition abuts the city limits at the northern boundary thereof.

THE COUNCIL OF THE CITY OF FARIBAULT, MINNESOTA ORDAINS:

Section 1. The city council hereby determines (1) that the territory described herein abuts upon the city limits and is about to become urban or suburban in character; and (2) that none of the territory is now included within the city limits of any city.


Section 2. Territory Annexed. The corporate limits of the city are hereby extended to include the unplatted land described as follows and the same is hereby annexed to and included within the city as effectually as if had been originally been a part thereof.

That part of the South One-half of the Northeast Quarter of Section 19, Township 110 North, Range 20 West of the Fifth Principal Meridian, Rice County, Minnesota, lying northwesterly and westerly from the northwesterly right of way line of Proposed Trunk Highway 3, excepting therefrom the West 264 feet of the South 1089 feet thereof; subject to existing Minnesota Trunk Highway 3 over the northwesterly corner of said South One-half of Northeast Quarter, containing about 5.8 acres, including said existing Highway 3.


Section 3. Filing. The City Administrator is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Board, the Secretary of State, the Town Clerk, and the County Auditor.

Section 4. Effective Date: This ordinance takes effect on January 6, 1986, upon its passage and publication and the filing of the certified copies as directed in Section 3, and approval of the ordinance by the Minnesota Municipal Board.




