

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF BRAINERD TO INCLUDE CERTAIN UNINCORPORATED TERRITORY COMPLETELY SURROUNDED BY LAND WITHIN THE CITY LIMITS OF THE CITY OF BRAINERD AND ABUTTING THEREON.

Ordinance No. _ 843

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city; and WHEREAS, this territory is completely surrounded on all sides by lands already included within the corporate limits of the City of Brainerd and is deemed to be urban or suburban in character;

SECTION ONE. The corporate limits of the City of Brainerd,
Minnesota, are hereby extended to include the following described
realty located in the County of Crow Wing, State of Minnesota:

THE CITY COUNCIL OF THE CITY OF BRAINERD DOES ORDAIN:

That portion of the Auditor's Subdivision of the Northwest Quarter (NW1/4), Section Twenty (20), Township Forty-five (45) North, Range Thirty (30) West of the Fourth Principal Meridian, according to the plat thereof on file in the office of the Crow Wing County Recorder, Crow Wing County, Minnesota, described as follows: Lot Eight (8) and the intervening portion of Rice Lake lying between Lot 7 and Lot 8 and also lying southerly of the north line of said Lots 7 and 8.

SECTION TWO. The City Clerk is directed to file certified copies of this ordinance with the Secretary of State, the Crow Wing County Auditor, the Town Clerk of the affected township and the Minnesota Municipal Board.

SECTION THREE. This ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section Two and approval by the Minnesota Municipal Board.
