An ordinance annexing certain unincorporated land abutting the City limits, and extending the corporate limits of the City of Goodview to include such land.

WHEREAS, a petition dated June 7, 1984, requesting annexation of the territory hereinafter described was duly presented to the City Council on \_\_\_\_\_\_March 11\_\_\_\_\_\_, 1985, and,

WHEREAS, the land described in the petition consists of platted lands and unplatted lands, not exceeding 200 acres in area, abutting the City of Goodview, no part of which is included within another municipality; and,

WHEREAS, the petition was signed and submitted by all owners of property within the land to be annexed; and

WHEREAS, no objections to the annexation have been submitted by the Town Board of the affected township, and no other municipality borders the land to be annexed; and,

WHEREAS, the City Council has determined that the land to be annexed is or is about to become urban or suburban in character, and that annexation of such land to the City of Goodview would be to the best interests of the City and of the territory affected, and that all legal requirements for annexation have been fulfilled; now therefore,

The City Council of the City of Goodview, Minnesota, ordains:

Section 1. Annexation.

The land described as follows is hereby annexed to the City of Goodview and included within the City of Goodview, and the corporate limits of the City of Goodview are hereby extended to include the land described as follows:

That part of the Southeast Quarter of the Southwest Quarter (SE 1/4 of SW 1/4) of Section Twelve (12), and of the Northeast Quarter of the Northwest Quarter (NE 1/4 of NW 1/4) of Section Thirteen (13), Township One Hundred Seven (107) North, of Range Eight (8), West of the Fifth Principal Meridian, Winona County, Minnesota, described as follows:

Commencing at the intersection of the Southerly right of way line of Old Highway No. 61 (County State Aid Highway No. 32) and the North-South centerline of said Section Twelve (12); thence Southerly and along the North-South centerline of said Section Twelve (12)

to the Northeast corner of the Northeast Quarter of the Northwest Quarter (NE 1/4 of NW 1/4) of said Section Thirteen (13); thence continuing Southerly on the East line of the Northeast Quarter of the Northwest Quarter (NE 1/4 of NW 1/4) of said Section Thirteen (13), a distance of 150 feet; thence Westerly and parallel with the North line of the Northeast Quarter of the Northwest Quarter (NE 1/4 of NW 1/4) of said Section Thirteen (13), a distance of 33 feet; thence Northerly and parallel with the East line of the Northeast Quarter of the Northwest Quarter (NE 1/4 of NW 1/4) of said Section Thirteen (13), and parallel to the East line of the Southeast Quarter of the Southwest Quarter (SE 1/4 of SW 1/4) of said Section Twelve (12), to the Southerly right of way line of County State Aid Highway No. 32; thence Easterly along the Southerly right of way line of County State Aid Highway No. 32 to the point of beginning; said parcel being the West half of a public road designated and known as Rollingstone Township Road No. 2, lying South of County State Aid Highway No. 32 and North of a line 150 feet South of and parallel to the North line of said Section Thirteen (13).

## Section 2. Effective Date.

This ordinance shall be filed with the Minnesota Municipal Board, Rollingstone Township, the County Auditor of Winona County, and the Secretary of State of the State of Minnesota, and shall be published in the official city newspaper; and the City Administrator is hereby authorized and directed to cause such filing and publication to be made forthwith. This ordinance shall take effect upon completion of such filing and publication, subject to approval by the Minnesota Municipal Board. This ordinance shall be final and the annexation shall be effective on the date the ordinance is approved by the Board.
