AN ORDINANCE OF THE CITY OF NORTH MANKATO, MINNESOTA
DECLARING CERTAIN LAND TO BE ANNEXED TO SUCH CITY, IDENTIFIED AS
LONEY AND KRUSE PROPERTIES.

THE CITY COUNCIL OF THE CITY OF NORTH MANKATO, MINNESOTA
ORDAINS:

Section 1. The following tract of unincorporated property
abuts upon the municipal limits of the City of North Mankato,
Minnesota.

Section 2. The legal description of said land is shown upon
Exhibit A, attached hereto and the same is incorporated herein by
reference.

Section 3. Such land is now or is about to become urban or
suburban in character.

Section 4. The land proposed for annexation is platted.


Section 5. 100% of the ownership interest in such land has
petitioned the North Mankato City Council to have such land
included within the municipal limits.

Section 6. The amount of acreage involved in this annexation
is 2.15.

Section 7. Such land is hereby annexed to the City of North

municipal limits.

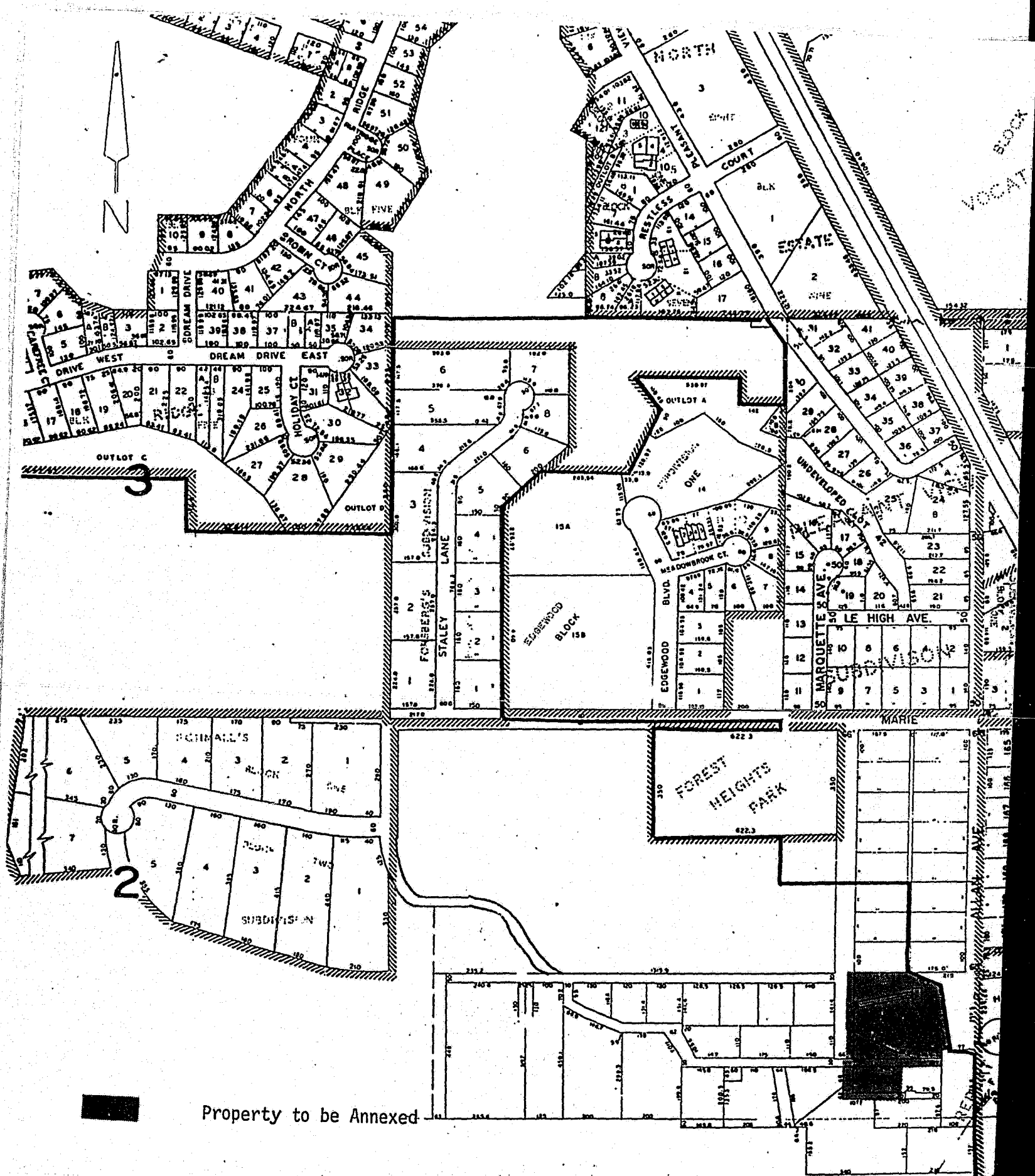
Section 8. After adoption, signing and attestation, this
