#### Ordinance No. 2803 AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF WINONA, MINNESOTA TO INCLUDE CERTAIN UNINCORPORATED LAND

WHEREAS, a Petition dated March 17, 1986, was presented to the City Council for the annexation of certain lands hereinafter described, and
