ORDINANCE NO. 33.

AN ORDINANCE ANNEXING CERTAIN LOTS AND BLOCKS AND OTHER LANDS TO THE VILLAGE OF ROSBAU.

The Village Council of the Village of Rosbau, do ordain as follows:-

SEC. 1. That the following described lots and blocks and other lands, viz:- All of that portion of the South half of the South West Quarter (S 1/2 SW 1/4) of Section Thirteen (13) Township one hundred and sixty-two (162) North of Range Forty (40) West of the Fifth Principal Meridian in Minnesota, lying East of the main channel of the Rosbau River, and which includes Blocks Three (3) Four (4) and Five (5) of Riverside Addition to the Village of Rosbau, according to the plat thereof, on file and of record, in the office of the Register of Deeds, Rosbau County Minnesota, abutting upon the incorporated Village of Rosbau, be and the same are hereby annexed to such village, and shall become a part of such village as effectually as if they had been originally a part thereof.

SEC. 2. This ordinance shall take effect and be in force after its passage and publication, and after a certified copy thereof has been filed with the County Auditor and the Secretary of State.

The foregoing ordinance was presented at a special meeting of the Village Council of the Village of Rosbau, held on the 27th, day of February, A.D. 1906, and was on said day passed by an affirmative vote of the majority of the members of the Village Council by an Aye and Nay vote; the following voting Aye: J.J. Ross, Trustee, A. Wang, trustee, E.J. Thompson, trustee, H. Brett, Village recorder and A.H. Ross, President. The following voting Nay: None. Absent and not voting: None.

The ordinance was passed by a unanimous consent of all the members present, and this action of the Village Council is noted in the records of said meeting.


