ORDER ORGANIZING THE TOWNSHIP OF CLAY

STATE OF MINNESOTA)
County of Hubbard)SS.

IN THE MATTER of the petition of a majority of the resident freeholders of the Unorganized District of Clay for the organization of the said District of Clay in Hubbard County, Minnesota:

The above entitled matter came on duly to be heard by the Board of County Commissioners of the County of Hubbard, at the Hubbard County Courthouse in the City of Park Rapids in said County, on Wednesday the 6th day of November, 1985, at 10:00 o'clock A.M., pursuant to notice duly given as provided by law and the order of said Board; and the said Board having heard all persons interested in said matter, both for and against, finds as follows:

First - That said petition was presented to said Board on the 5th day of September, 1985; was signed and acknowledged by a majority of the freeholders qualified to vote, residing in the Unorganized District above specified.

Second - That notice of said hearing on said petition was duly given by publication of the order of said Board for said hearing in the newspaper known as the Park Rapids Enterprise published in said County, at least ten days prior to said day of hearing; and by the posting of copies of said order in three of the most public places in said district above specified for at least thirty days before said day of hearing; and by service of said order by mail upon each of the Clerks of adjacent Townships at least ten days before said day of hearing as provided by law.

Third - That the District proposed to be organized contains thirty-six square miles within its boundaries, contains at least twenty-five qualified voters therein, and had an assessed valuation of \$1,336,227. as of January 1, 1985.

Fourth - That it is expedient and for the best interests of the residents of said District and the County of Hubbard that said District be organized as a Township.

NOW, THEREFORE, IT IS ORDERED, That said petition be, and the same hereby is granted, and that said Township be named CLAY TOWNSHIP; that the boundaries of said Township be the same as the boundaries of the District as the same exists as of this date, and that the funds remaining in the account of the District at the time of its organizational meeting be turned over to the Treasurer of the Township after it is properly organized.

IT IS FURTHER ORDERED, That a copy of this Order be sent to the Minnesota State Auditor, the Secretary of State of the State of Minnesota, and the Minnesota Commissioner of Revenue.




BE IT ORDERED that the First Town Meeting of said Clay Township be held on Thursday, November 21, 1985, at 7:00 o'clock P.M. at the Emmaville Store at the intersection of C.S.A.H. #4 and C.S.A.H. #24 in SE $\frac{1}{4}$ of SE $\frac{1}{4}$, Sec. 33, Twp. 142 N, R. 34 W., at which time and place the voters present at the meeting shall choose one of their number as moderator, two others as judges of election, and one as clerk, who shall severally take the required oath and thereupon conduct the proceedings of the meeting according to law, including the election of township officers and such other matters as may properly come before the voters.

BE IT FURTHER ORDERED, that copies of this Order be posted within the Township at least ten days before the meeting as required by law.






