



FINDINGS OF FACT,  
CONCLUSIONS OF LAW,  
AND ORDER

On July 1, 1986, the Minnesota Municipal Board received a resolution from the City of Mankato, which requested the detachment of certain property and the City of North Mankato, which requested the annexation of the same territory pursuant to Minnesota Statutes 414.061.

After review of the resolutions, the Minnesota Municipal Board hereby makes and files the following Findings of Fact, Conclusions of Law, and Order.

FINDINGS OF FACT

1. That a resolution supporting detachment of certain property was received from the City of Mankato and a resolution supporting annexation of said property was received from the City of North Mankato.

2. The resolutions contained all the information required by statute including a description of the territory proposed for detachment and annexation, which is as follows:

That part of Government Lot 2, Section 1, Township 108 North, Range 27 West, Blue Earth County, Minnesota, described as:

Commencing at the northeast corner of Government Lot 2, Section 1, Township 108 North, Range 27 West; thence south 00 degrees 00 minutes 48 seconds west along the east line of Government Lot 2, a distance of 1,159.33 feet; thence north 89 degrees 59 minutes 12 seconds west,

725.94 feet; thence south 00 degrees 00 minutes 48 seconds west, 410.75 feet to the point of beginning; thence continuing south 00 degrees 00 minutes 48 seconds west, 101.36 feet to a point on the centerline of the old Minnesota River channel; thence south 63 degrees 00 minutes 00 seconds west along the centerline of the old river channel as witnessed by the resurvey of the right bank government meanders, completed by Tom Mackey, Minnesota Registration No. 1817, on September 25, 1962, a distance of 353.27 feet; thence south 83 degrees 23 minutes 57 seconds west along the old river channel centerline 261.21 feet; thence north 63 degrees 23 minutes 52 seconds west along the old river channel centerline 328.21 feet; thence north 15 degrees 30 minutes 00 seconds west along the old river channel centerline 150.48 feet; thence south 89 degrees 59 minutes 12 seconds east, 907.95 feet to the point of beginning.

3. The area proposed for detachment is situated within the City of Mankato and abuts the municipal boundary of the City of North Mankato.

CONCLUSIONS OF LAW

1. The Minnesota Municipal Board duly acquired and now has jurisdiction of the within proceeding.
2. An order should be issued by the Minnesota Municipal Board concurrently detaching and annexing the area described herein.

ORDER

1. IT IS HEREBY ORDERED: That the property described in Findings of Fact 2 be, and the same hereby is, detached from the City of Mankato and annexed to the City of North Mankato, the same as if it had originally been made a part thereof.
2. IT IS FURTHER ORDERED: That the effective date of this order is July 10, 1986.
