

AGREEMENT BETWEEN THE CITY OF AUSTIN)
AND THE TOWN OF AUSTIN PURSUANT TO)
MINNESOTA STATUTES 414)

ORDER

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Austin and the Town of Austin and duly accepted by the Minnesota Municipal Board; and

WHEREAS, a resolution was received from the City of Austin indicating their desire that certain property be annexed to the City of Austin pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 requires that the Minnesota Municipal Board review and comment, but within 30 days approve the annexation of land pursuant to said subdivision; and

WHEREAS, on August 14, 1986, the Minnesota Municipal Board has reviewed and approved the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Austin, Minnesota, the same as if it had originally been made a part thereof:


Beginning at the northwest corner of Lot 6, Block 3, Austin Homesteads in the NW1/4 of Section 9, T102N, R18W, Mower County Minnesota, thence westerly on a line parallel to the north line of said Lot 6 to the centerline of 21st St. S.W. thence northerly on the centerline of 21st St. S.W. to a point that intersects the south line of Lot 6, Block 4, Austin Homesteads, extended easterly. Thence westerly along the south line of said Lot 6 to the southwest corner of said Lot 6 thence northerly along the west line of said Lot 6 to

the northwest corner of said Lot 6 this point also being on the south property line of 12th Ave. S.W. thence easterly along the south property line of 12th Ave. S.W. a distance of 240 feet thence southerly on a line parallel to the west line of said Lot 6 to a point that is 120 feet north of the south line of said Lot 6 thence easterly on a line parallel to the south line of said Lot 6 to the west property line of 21st St. S.W. thence northerly along said west property line to a point that intersects a line extended westerly that is 17.15 feet south and parallel to the north line of Lot 3, Block 3 of Austin Homesteads thence easterly on this extended line to a point that is 253 feet west of the east line of said Lot 3 thence southerly on a line parallel to said east line to the south line of said Lot 3 thence westerly along said south line of Lot 3 to east property line of 21st St. S.W. thence southerly on said east property line to the point of beginning.

IT IS FURTHER ORDERED: That the effective date of this order is August 14, 1986.
