ORDINANCE NO. 9

AN ORDINANCE EXTENDING THE CORPORATE LIMITS
OF THE CITY OF DETROIT LAKES, MINNESOTA TO INCLUDE CERTAIN
UNINCORPORATED TERRITORY COMPLETELY SURROUNDED BY LAND WITHIN THE
CITY LIMITS AND ABUTTING THEREON

WHEREAS, certain territory described below is not presently included within the corporate limits of any incorporated city, or borough; and

WHEREAS, this territory is completely surrounded on all sides by lands already included within the corporate limits of the City and is deemed to be urban or suburban in character;

The City Council of the City of Detroit Lakes, Minnesota, does ordain:

Section 1. The corporate limits of the City of Detroit Lakes, Minnesota, are hereby extended to include the unplatted territory described as follows, which territory now is and has heretofore been completely surrounded by territory already included within the City limits:

That part of the N 1/2 of the NE 1/4 Section 10, T138N, R41W not previously annexed.

Section 2. The City Administrator is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the County in which the property is located, the Town Clerk of the affected township and the Minnesota Municipal Board.

Section 3. This ordinance takes effect upon passage and publication and filing of certified copies as directed in Section 2 and approval by the Minnesota Municipal Board.



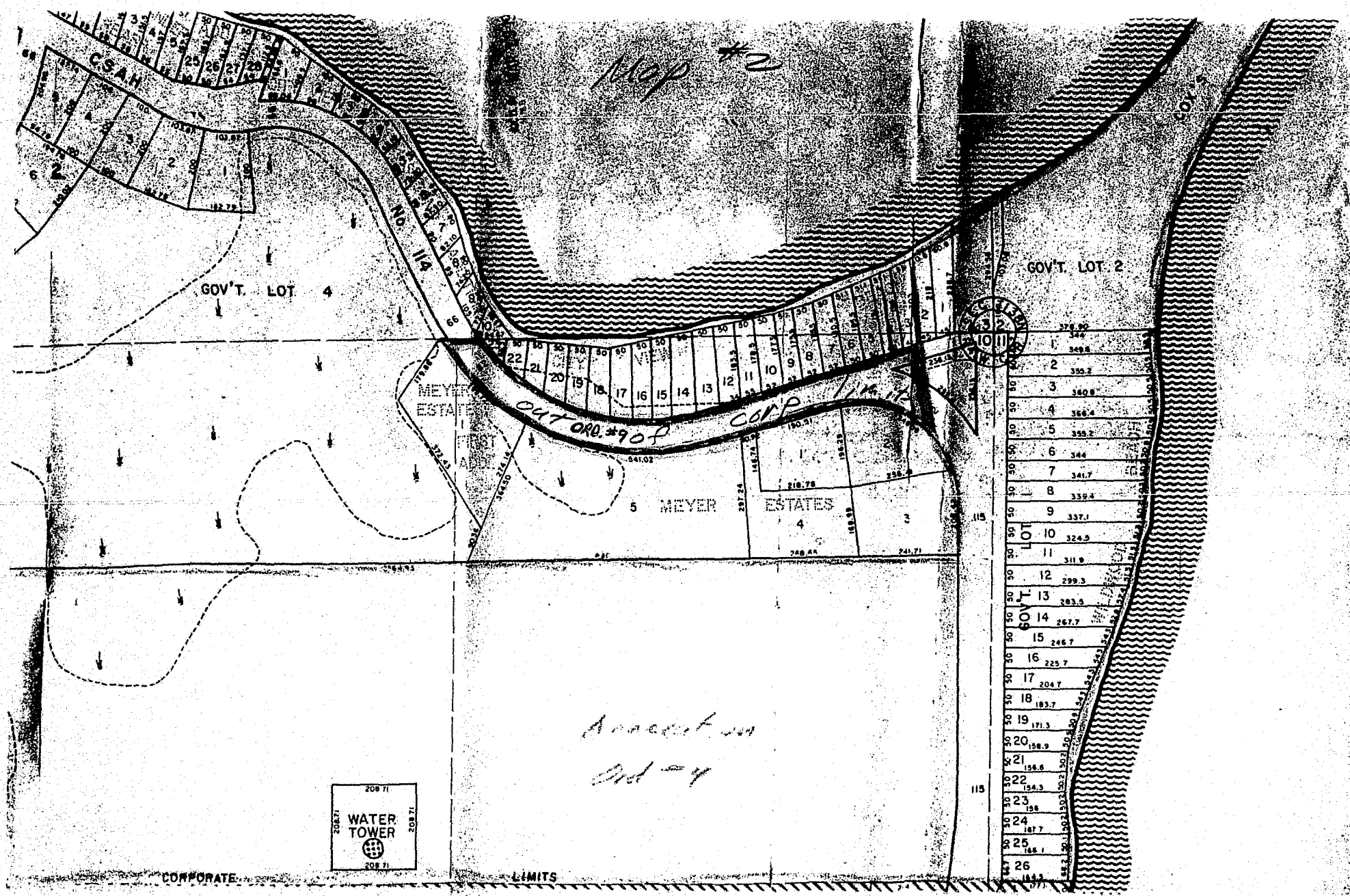
