

ORDER

WHEREAS, a joint resolution for orderly annexation was adopted by the City of North Mankato and the Town of Belgrade and duly accepted by the Minnesota Municipal Board; and

WHEREAS, a resolution was received from the City of North Mankato indicating their desire that certain property be annexed to the City of North Mankato pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 requires that the Minnesota Municipal Board review and comment, but within 30 days approve the annexation of land pursuant to said subdivision; and

WHEREAS, on August 14, 1986, the Minnesota Municipal Board has reviewed and approved the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of North Mankato, Minnesota, the same as if it had originally been made a part thereof:

- Lot 1 and 1A, Auditor's Plat No. 1
- Lot 3, Auditor's Plat No. 1
- Lot 4, Auditor's Plat No. 1
- Lot 5, Auditor's Plat No. 1

Lot 8, Auditor's Plat No. 1

Lot 10, Auditor's Plat No. 1

Lot 14, the South 97.6 ft. of Lot 16, Auditor's Plat No. 1, plus  
Outlot A, Tompkins Subdivision.

All that part of Lot 23 and Lot 34, Auditor's Plat No. 1 not already  
annexed into the City of North Mankato. These lots are dedicated  
road right-of-way.

Lots 1 and 2, Block 1, Tompkins Subdivision.


Lot 3, Block 1, Tompkins Subdivision.


All the parcels are located in Nicollet County, Minnesota, and total
