
The Minnesota Municipal Board has now processed and approved the above ordinance in accordance with Minnesota Statutes, Chapter 414, and the Rules of Procedure.



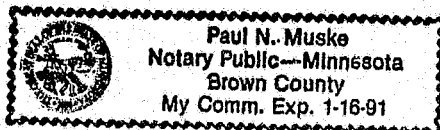

ORDINANCE NO. 283

AN ORDINANCE ANNEXING CERTAIN TERRITORY

The City Council of the City of Springfield, Minnesota, does ordain:

That the following described territory is hereby annexed to the City of Springfield and the City corporate limits are hereby extended to include the same, to wit:

Part of the Southeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$ SE $\frac{1}{4}$), Section Thirteen (13), Township One Hundred Nine (109), Range Thirty-five (35), Brown County, Minnesota, described as: Beginning at the Southeast corner of the Southeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$ SE $\frac{1}{4}$) of said Section 13, thence North along the East line of said Section 13, 197.00 feet, thence at right angles West to the Southwest corner of Lot B of said Southeast Quarter of Southeast Quarter (SE $\frac{1}{4}$ SE $\frac{1}{4}$), thence South parallel to the East section line to the South line of said Section 13, thence East to the point of beginning.
