AN ORDINANCE AMENDING ORDINANCE NO. 239

WHEREAS, the Alexandria City Council adopted Ordinance No. 239 on October 28, 1985 for the purpose of annexing certain unincorporated land to the City, and

WHEREAS, upon review of this Ordinance the Minnesota Department of Transportation found an error in the legal description of the subject property as described on the tax records of Douglas County:

NOW THEREFORE BE IT ORDAINED by the City Council of the City of Alexandria, Minnesot that:


SECTION I. Ordinance No. 239 be hereby amended by changing the legal description in Section II of Ordinance No. 239 to read as follows:

The legal description of the property in question is the South 261.9 feet of Lot E of Auditor's Subdivision of the West $\frac{1}{2}$ of the NW $\frac{1}{4}$ of Section 17, Township 128 North, Range 37 West, lying West of Sunnyside Drive, East of the Northeasterly right-of-way of T.H. No. 29 and lying south of Lot 1, Block 1, Jelsing's Sunny Acres Addition (Parcel Number 03-1437-000).


