RESOLUTION 1-84-18

APPROVING AN ORDINANCE ANNEXING CERTAIN LANDS
LOCATED IN THE TOWN OF GRAND RAPIDS TO THE CITY OF LA PRAIRIE

WHEREAS, there has been filed with the State of Minnesota Municipal Board a Petition by DMN, Inc., for the annexation of certain lands located in the Town of Grand Rapids, adjacent to the City of LaPrairie, and

WHEREAS, the Petitioner for the annexation of said lands was dated May 2, 1983, and

WHEREAS, the Petition was served upon the City of Grand Rapids, which joints said tract, and the Town of Grand Rapids, and

WHEREAS, the Town of Grand Rapids and the City of Grand Rapids have both, at regularly scheduled meetings considering said Petition for Annexation of lands of the City of LaPrairie, and consented to said annexation, and waived any notice of hearing, and

WHEREAS, in all respects the application and petition submitted by the City of LaPrairie and the State of Minnesota Municipal Board appears to be in order,

THEREFORE BE IT RESOLVED:

1. That the City of LaPrairie herewith pass an Ordinance annexing the lands located in the County of Itasca, State of Minnesota:

The West one-half ($W\frac{1}{2}$) of Lot Eight (8), Hoolihan's Addition to Grand Rapids, according to the Plat thereof on file and of record in the office of the Itasca County Recorder,

And those lands lying Northwesterly thereof, up to and including up to the centerline of the right of way of U.S. Highway No. 169.

2. That said annexation be made pursuant to Minnesota Statutes 414.033.

3. That further no building permit be issued for the construction of any improvements upon the lands described herein, without the connection of said improvement to the City of Grand Rapids sanitary sewer system, located in the City of LaPrairie.

4. That further the proposed subdivision of the above described property be consistant with the City of LaPrairie zoning ordinance in effect as of this date.
