

AN ORDINANCE ANNEXING PROPERTY  
TO THE CORPORATE LIMITS  
OF THE CITY OF MANKATO

WHEREAS, certain property described below is not presently included in the corporate limits of any incorporated city, village, or borough; and

WHEREAS, pursuant to Minnesota Statutes 414.033, Subd. 5, a majority of the owners of said described property described below have petitioned the City of Mankato for annexation of such property; and

WHEREAS, the property is located adjacent to existing City boundaries and can be served with public utilities; and

WHEREAS, the Council of the City of Mankato finds that the property is about to become urban in character and no objections to the annexation have been received.

NOW, THEREFORE, the Council of the City of Mankato hereby ordains that the corporate limits of the City are hereby extended to include the land described as follows and the same is hereby annexed to and included within the City of Mankato as effectively as if it had originally been a part thereof:

That part of the Southeast Quarter of the Southeast Quarter of Section 9, Township 108 North, Range 26 West, described as:

Beginning at the Southeast corner of the Southeast Quarter of the Southeast Quarter of Section 9, Township 108 North, Range 26 West; thence North along the Section line a distance 330 feet; thence Westerly at an angle of 90 degrees 14 minutes, a distance of 483 feet; thence Southerly a distance of 300 feet to the Section line; thence Easterly along the South Section line a distance of 483 to the place of beginning being 3.66 acres.


The North 50 feet of the Northeast Quarter of the Northeast Quarter of Section 16, Township 108 North, Range 26 West, consisting of Minnesota Highway right-of-way (1.52 acres).

The City Clerk is hereby directed to file copies of this Ordinance with the Minnesota Municipal Board, the Secretary of State, the Blue Earth County Auditor, and the Mankato Town Board.

This Ordinance shall take effect 30 days after its passage, due publication thereof, and approval by the Minnesota Municipal Board.
