WHEREAS, a joint resolution for orderly annexation was adopted by the City of Hastings and the Town of Marshan and duly accepted by the Minnesota Municipal Board; and

WHEREAS, an amendment to the joint resolution was adopted by the City of Hastings and the Town of Marshan and duly accepted by the Minnesota Municipal Board; and

WHEREAS, the amendment to the joint resolution indicated their desire that certain property be immediately annexed to the City of Hastings pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 requires that the Minnesota Municipal Board review and comment, but within 30 days approve the annexation of land pursuant to said subdivision; and

WHEREAS, on September 11, 1986, the Minnesota Municipal Board has reviewed and approved the amendment to the joint resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Hastings, Minnesota, the same as if it had

originally been made a part thereof:


Lot Seven, Block Two, Sieben's First Addition, 16180 LeRoy Avenue, Hastings, Minnesota, located in Marshan Township, Dakota County, Minnesota.

IT IS FURTHER ORDERED: That the mill levy of the City of Hastings on the property herein ordered annexed shall be increased in substantially equal proportions over a period of four years to equality with the mill levy of the property already within the city.

IT IS FURTHER ORDERED: That the effective date of this order is September 11, 1986.
