
The Minnesota Municipal Board has now processed and approved the above ordinance in accordance with Minnesota Statutes, Chapter 414, and the Rules of Procedure.

The annexation is final upon the date the ordinance is approved by the Board, which is the date of this letter.



AN ORDINANCE ANNEXING
FRANCES GULBRANDSON PROPERTY
TO THE CITY OF GARFIELD

WHEREAS, the City of Garfield has been presented with a petition from Frances C. Gulbrandson requesting annexation of certain lands described on Attachment #1 hereto to the City of Garfield, Minnesota; and

WHEREAS, the City of Garfield has, pursuant to Minnesota Statutes §414.033, filed the petition and supporting documents with the State of Minnesota Municipal Board; and

WHEREAS, the City of Garfield has been presented with a waiver by Ida Township registering their consent and concurrence with the annexation and waiving any and all objections to the annexation as requested;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF GARFIELD, MINNESOTA, that the lands described on Attachment #1 to this ordinance shall be and hereby are annexed to the City of Garfield, Minnesota, and the boundaries of the City of Garfield, Minnesota, shall be adjusted on the official boundary map to reflect the inclusion of the subject property.

That this ordinance shall be in full force and effect from and after its passage and publication.



ATTACHMENT #1

All that part of the Northwest Quarter of the Southeast Quarter (NW $\frac{1}{4}$ SE $\frac{1}{4}$) of Section Thirty-two (32), Township One Hundred Twenty-nine (129), Range Thirty-eight (38), described as follows: Beginning at the Northwest corner of the Northwest Quarter of the Southeast Quarter (NW $\frac{1}{4}$ SE $\frac{1}{4}$) of said Section 32, said Township and Range, running thence South on the West line of said Quarter 32 rods; thence East and parallel to the North line of said Quarter 10 rods; thence North and parallel to the West line of said Quarter 32 rods; thence West 10 rods to the place of beginning;

except a strip of land 20 feet wide along the West line of said Quarter which is reserved for a road.


