

WHEREAS, a resolution was received from the City of Buffalo and the Town of Buffalo indicating their desire that certain property be immediately annexed to the City of Buffalo pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 requires that the Minnesota Municipal Board review and comment, but within 30 days approve the annexation of land pursuant to said subdivision; and

WHEREAS, on December 11, 1986, the Minnesota Municipal Board has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Buffalo, Minnesota, the same as if it had


originally been made a part thereof:


IT IS FURTHER ORDERED: That the effective date of this order is December 11, 1986.
