
The Minnesota Municipal Board has now processed and approved the above ordinance in accordance with Minnesota Statutes, Chapter 414, and the Rules of Procedure.


The annexation is final upon the date the ordinance is approved by the Board, which is the date of this letter.

ORDINANCE NO. 406

AN ORDINANCE ANNEXING A PART OF REAL PROPERTY  
ABUTTING THE TERRITORIAL LIMITS OF THE CITY OF CHASKA

The City of Chaska Do Ordain:

Section I. Preamble.

WHEREAS, all of the property owners of the hereinafter described property, together with the Town Board of the Township of Chaska, Carver County, Minnesota, duly petition the City of Chaska for the annexation of said after described real property to the City of Chaska pursuant to Minnesota Statutes in such case made and provided.

Section II. Annexation of Property.

That the hereinafter described real property is hereby annexed to the City of Chaska pursuant to Minnesota Statutes, Section 414.033, said property being described as follows, to-wit:

Parcel A. Commencing at the Northeast corner of the Northwest Quarter of Section 5-115-23, thence westerly along the North line of said Northwest Quarter 166 feet; thence South and parallel to East line of said Northwest Quarter 241 feet to center line of Chaska Victoria Road, Carver County Road No. 11, thence Southeast along center line of said road to East line of Northwest Quarter, thence North along said East line to point of beginning. Carver County, Minnesota.


Section III. Ward Boundaries.

Said above described real property annexed to the City of Chaska as provided in Section II hereof shall become a part of the First Ward of the City of Chaska.

SECTION IV. EFFECTIVE DATE.

This Ordinance shall be in full force and effect from and after its passage, adoption and publication according to law and filing same with the Township of Chaska, Carver County Auditor, the Secretary of State of the State of Minnesota, the Carver County Recorder and approval by the Municipal Board.

Passed and adopted by the City Council of the City of Chaska this day of October 1986.


