AMENDING THE LEGAL DESCRIPTION OF
ORDINANCE NO. 0-86-0714-219
ADOPTED BY THE CITY OF MANKATO

WHEREAS, The Council of the City, on the 14th day of July, 1986, adopted Ordinance No. 0-86-0714-219, annexing certain described property to the City of Mankato; and

WHEREAS, the description of such property described has been found to have a typographical error; and

WHEREAS, the Council wishes to amend such description in Ordinance No. 0-86-0714-219.

NOW, THEREFORE, the Council of the City of Mankato hereby ordains that the following is the correct description of property annexed by Ordinance No. 0-86-0714-219:

That part of the Southeast Quarter of the Southeast Quarter of Section 9, Township 108 North, Range 26 West, described as:

Beginning at the Southeast corner of the Southeast Quarter of the Southeast Quarter of Section 9, Township 108 North, Range 26 West; thence North along the Section line a distance 330 feet; thence Westerly at an angle of 90 degrees 14 minutes, a distance of 483 feet; thence Southerly a distance of 330 feet to the Section line; thence Easterly along the South Section line a distance of 483 to the place of beginning being 3.66 acres.

AN ORDINANCE ANNEXING PROPERTY
TO THE CORPORATE LIMITS
OF THE CITY OF MANKATO

WHEREAS, certain property described below is not presently included in the corporate limits of any incorporated city, village, or borough; and

WHEREAS, pursuant to Minnesota Statutes 414.033, Subd. 5, a majority of the owners of said described property described below have petitioned the City of Mankato for annexation of such property; and

WHEREAS, the property is located adjacent to existing City boundaries and can be served with public utilities; and

WHEREAS, the Council of the City of Mankato finds that the property is about to become urban in character and no objections to the annexation have been received.

NOW, THEREFORE, the Council of the City of Mankato hereby ordains that the corporate limits of the City are hereby extended to include the land described as follows and the same is hereby annexed to and included within the City of Mankato as effectively as if it had originally been a part thereof:

That part of the Southeast Quarter of the Southeast Quarter of Section 9, Township 108 North, Range 26 West, described as:



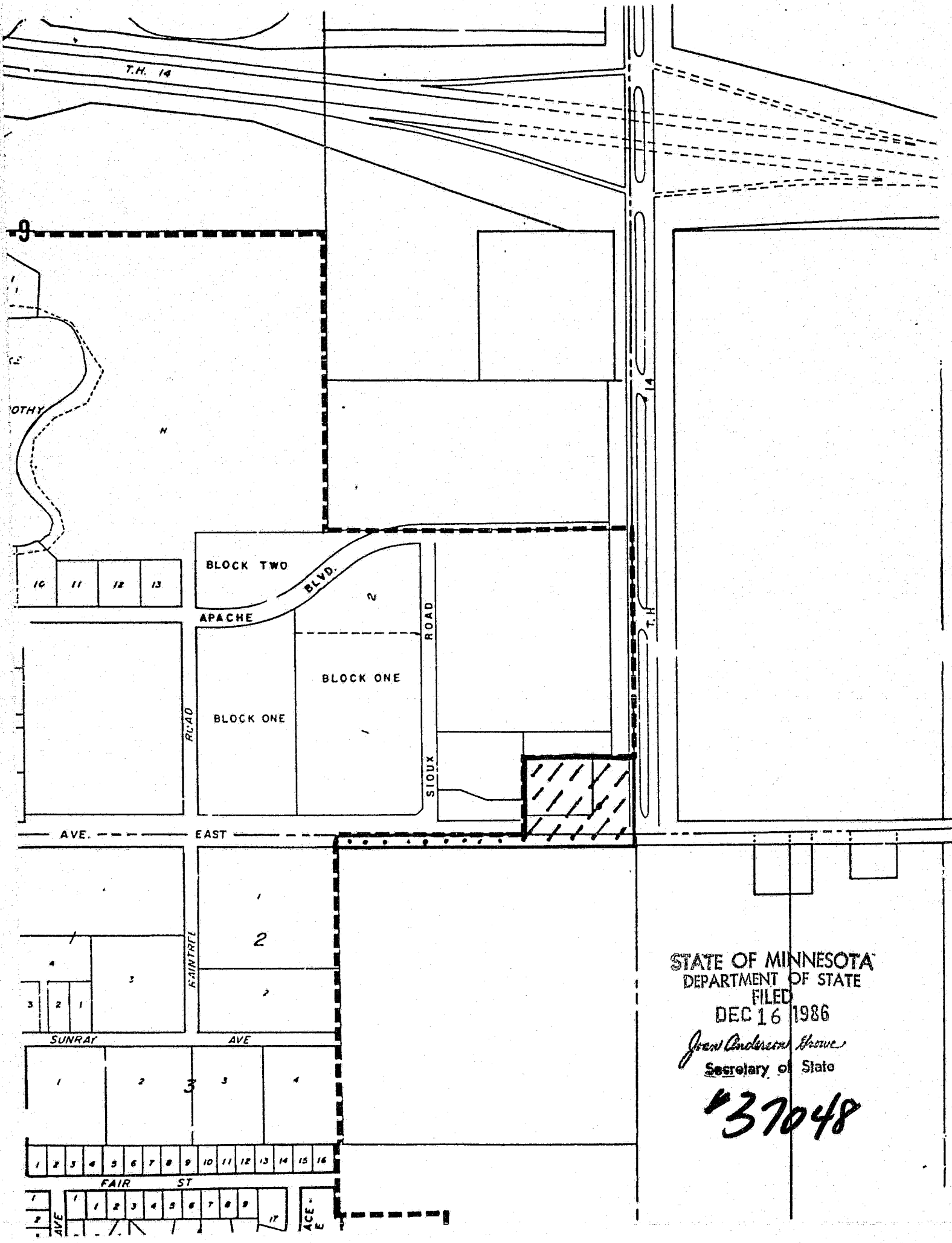
