REORGANIZATION ORDER NO. 139

Pursuant to Minnesota Statutes, 1986, Section 16B.37, the following administrative reorganization order is made with the prior approval of the Governor.

In order to improve the efficiency and avoid duplication of effort in the operation of state government, the Agricultural Trade Division, the Communications Division, the Export Services Division, the International Trade Division, the Minnesota Export Finance Authority and the Office of the Governor's Special Trade Representative (collectively organized as the Minnesota Trade Office); are transferred from the Department of Agriculture to the Department of Energy and Economic Development.

The current general fund legislative complement of the Department of Agriculture is decreased by thirty-eight positions and the general fund legislative complement of the Department of Energy and Economic Development is increased by thirty-eight positions.

The following position control numbers, classifications and incumbents with all accrued benefits are transferred from the Department of Agriculture to the Department of Energy and Economic Development in accordance with the provisions of Minnesota Statutes 1986, Section 15.039.

Fiscal and administrative support for the above positions shall be provided by the transfer from the Department of Agriculture to the Department of Energy and Economic Development of two additional legislative complement general fund positions selected by the Commissioner of Agriculture. These shall be occupied positions approved by the Commissioner of Administration or they shall be vacant positions.

In addition, the following non-complement temporary position is also transferred to the Department of Energy and Economic Development:

The powers and duties contained in the following Minnesota Statutes 1986 are transferred from the Commissioner of Agriculture to the Commissioner of Energy and Economic Development:

17.03 Subdivision 1. Development of Agricultural Industries. Only those powers and duties that encourage and promote the development of agricultural industries; investigate marketing conditions; assist development of cooperative enterprises and cooperative marketing; and assist in the establishment of local markets are transferred. All other powers and duties in the subdivision are retained by the Commissioner of Agriculture.

17.03 Subdivision 5. International Investment

17.101 Promotional Activities

17.1015 Promotional Expenses

17.102 Minnesota Products, State Logo or Label

17.103 Trade and Export Development.

17.104 Definitions

17.105 Export Finance Authority

Personnel, powers and duties of the Commissioner of Agriculture under the Agricultural Commodities Promotion Act, Minnesota Statutes 1986, Sections 17.51 to 17.69 are specifically not transferred to the Commissioner of Energy and Economic Development. Likewise, the powers and duties of Minnesota Statutes 1986 Sections 17.691 to 17.701, the Agricultural Marketing and Bargaining Act of 1973, are not transferred and remain with the Commissioner of Agriculture.

The Commissioner of Energy and Economic Development may continue to utilize existing services and facilities of the Department of Agriculture and be billed in accordance with a plan approved by the Commissioner of Administration and the Commissioner of Finance as provided in Minnesota Statutes 1986, Section 16B.37, Subdivisions 3 and 4. Except, however, no charge shall be made for word processing services as currently provided until the Minnesota Trade Office vacates its present offices in the Department of Agriculture building. No word processing personnel presently serving the needs of the Trade Office are transferred to the Department of Energy and Economic Development.



The Commissioner of Finance shall make the necessary financial determinations in accordance with Minnesota Statutes 1986, Section 16B.37 Subdivision 3.


