REORGANIZATION ORDER NUMBER 140

Pursuant to Minnesota Statutes Section 16B.37 the following reorganization order is made with the prior approval of the Governor.

This reorganization order is made to improve the efficiency of state government and to provide a more integrated program of energy services to the citizens of Minnesota, by transferring the Energy Division (as defined in Minn. Stat. Section 116J.01, Subd. 3) of the Minnesota Department of Energy and Economic Development (DEED) to the Minnesota Department of Public Service (DPS). This transfer includes all the statutory duties, obligations, and authority now vested in DEED as enumerated herein. This reorganization order does not transfer all or substantially all of the powers, duties, or personnel of DEED.

The duties, obligations, power, tasks, functions, programs, and authority now given by Minn. Stat. Section 116J.04 through 116J.381, Section 325F.19 through 325F.24, and Section 13.68 to DEED, including the authority to enforce, maintain, alter, amend, rescind, and vary all rules issued by DEED or any predecessor agency under those sections of the law, are hereby transferred to DPS.

The following Statutes which specify duties, powers, tasks and programs, are hereby transferred in their entirety from DEED to DPS.

The powers and duties of both the Commissioner of DEED and the energy and economic development authority in this section are transferred to DPS.

All power and authority set forth in Minn. Stat. Section 116J.035 remain with the Commissioner of DEED except as specified below:

The power to apply for, receive, and expend money from municipal, county, regional, and other government agencies for the purposes of Sections 116J.04 through 116J.381 is hereby transferred from DEED to DPS.

The power to apply for, accept, and disburse grants and other aids from other public or private sources for the purposes of Sections 116J.04 through 116J.381 is hereby transferred from DEED to DPS.

The power to contract for professional services for energy related purposes if such work or services cannot be satisfactorily performed by employees of the department or by any other state agency is hereby transferred from DEED to DPS.

The power to enter into interstate compacts to jointly carry out energy related research and planning with other states or the federal government where appropriate is hereby transferred from DEED to DPS.

The power to distribute energy related informational material at no cost to the public upon reasonable request within the meaning of Section 116J.035 Subd. 1(e) is hereby transferred from DEED to DPS.

The power to enter into contracts necessary for the performance of the duties transferred by this order, with federal, state, regional, metropolitan, local, and other agencies or units of governments and educational institutions, including the University of Minnesota, is hereby transferred from DEED to DPS. Contracts made for such purposes shall not be subject to the competitive bidding requirements of chapter 16.

The power to apply for, receive, and expend money made available from federal or to other sources for the purpose of carrying out the duties and responsibilities transferred by this order is hereby transferred from DEED to DPS.

All moneys received by the director of DPS pursuant to Sections 116J.04 through 116J.381 shall be deposited in the state treasury and are appropriated to the director of DPS for the purpose for which the moneys have been received. The money shall not cancel and shall be available until expended.

The power to adopt rules pursuant to chapter 14 as necessary to carry out the duties and responsibilities pursuant to Sections 116J.04 through 116J.381, is hereby transferred from DEED to DPS.

The authority to apply for, receive and administer all federal energy programs and funds other than the crisis fuel assistance and low income weatherization program, which are under the Department of Jobs and Training, is transferred from DEED to DPS.

The authority to apply for, receive, disperse and administer money resulting from litigation or settlements of alleged violations of federal petroleum pricing regulations, is transferred from DEED to DPS.

All rulemakings in progress and the authority to make future rules with regard to the Statutes transferred by this order, are also transferred from DEED to DPS. They include rulemaking regarding Insulation Standards published in the State Register on May 12, 1986; Rental Standards published in the State Register on May 5, 1986, and Community Energy Initiatives published in the State Register on November 10, 1986.

The funding, programs and complement provided through the Legislative Commission on Minnesota Resources to DEED for the Biomass

Cash Crop Project and the Demonstration Project for Heat Extraction from Groundwater for Public Buildings, are hereby transferred to DPS.

All pending obligations of DEED in regard to the above transfers, including but not limited to contracts, grants, interagency agreements and rulemaking, are hereby transferred to DPS.

Consistent with this transfer of authority the legislative complement of the Department of Energy and Economic Development is decreased by, and the legislative complement of the Department of Public Service is increased by, 38.25 General Fund positions, 33.5 Federal Fund positions, and 1.0 Minnesota Resources Fund position. The following existing positions and their incumbents are transferred to the Department of Public Service with all accrued rights and benefits:

Any grant agreements or other contractual arrangements relating to the transferred programs shall be amended to reflect the change in responsible state agency.

DPS shall have continued use of and access to all equipment, furnishings, supplies and leased space. Ultimate transfer will be made as agreed by the Commissioner of Energy and Economic Development and the Director of Public Service.

The Director of Public Service may continue to utilize existing services and facilities of the Department of Energy and Economic Development and be billed, according to actual use, in accordance with a plan approved by the Commissioner of Finance under Minnesota Statutes 1984, Section 16B.37, subdivision 3.

The Commissioner of Finance shall make the necessary financial determinations in accordance with Minnesota Statutes Section 16B.37 Subdivision 3.

Through the end of Fiscal year 1987 Federal energy funds that are used for positions retained by DEED, shall remain with DEED. Accountability and all reports to the Federal government regarding such funds shall be the responsibility of DEED.

The current interagency agreement between DEED and the Minnesota Environmental Quality Board (EQB) concerning the Advance Forecast of electrical demand, shall remain the responsibility of DEED. The positions and funding provided by this agreement shall remain with DEED.

All costs associated with the federally funded positions remaining with DEED including but not limited to indirect costs, salary, fringe benefits, vacation, insurance and all severance costs and unemployment compensation, shall be the responsibility of DEED.

Continued access to and use of the Energy Forecasting Model, the Regional Energy Information System (REIS), all library materials, and all other pertinent data, information and materials shall be furnished by DEED to DPS. Their ultimate transfer will be determined by agreement of the Commissioner of DEED and the Director of DPS.

Fiscal support services for the personnel and programs transferred to DPS by this order shall be furnished by DEED for the remainder of Fiscal Year 1987 at no cost to DPS. During such time period DEED shall provide instructions and training on the procedures, methods and materials of the accounts and transactions transferred, to selected DPS personnel.



All Federal energy indirect funds shall be transferred from DEED to DPS.





The effective date of this Order is December 26, 1986. The Order is herewith filed with the Secretary of State and shall remain in effect until amended or repealed.


