

ORDER

WHEREAS, a joint resolution for orderly annexation was adopted by the City of North Mankato and the Town of Belgrade and duly accepted by the Minnesota Municipal Board; and

WHEREAS, said joint resolution requested that certain property be immediately annexed to the City of North Mankato pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 requires that the Minnesota Municipal Board review and comment, but within 30 days approve the annexation of land pursuant to said subdivision; and

WHEREAS, on January 8, 1987, the Minnesota Municipal Board has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property in Belgrade Township, Nicollet County is hereby annexed to the City of North Mankato, Minnesota, the same as if it had originally been made a part thereof: The right-of-ways of Park View Court in Park View Subdivision.

IT IS FURTHER ORDERED: That the effective date of this order is January 8, 1987.
