Excerpt from Board Proceedings - March 3, 1987

At this time, a group of citizens representing the Otter Tail Peninsula area met with the Board on the proposed organization of Otter Tail Peninsula. Spokesperson Norman Hansen lead the discussion and outlined proposed boundaries of the township and presented the petition to the Board. There being no persons present in opposition to the petition to organize, and the petition being found to be in order, pursuant to Minnesota Statute 379.01 Subd. 2, the following action transpired:

Commissioner Ostlund offered the following Resolution No. 14-87 and moved its adoption.

WHEREAS, Upon receiving a petition of a majority of resident freeholders, who are legal voters of Congressional Townships Number 144 North, of Range 29 and 30 West and a portion of Township 143 North, Range 30 West, in Cass County, asking that the same be organized as a new township and that the Cass County Board of Commissioners proceed to fix and determine the boundaries of such new township to include the following territory:

All of that part of Unorganized Five contained within Townships 144 North, Range 29 West and Township 144 North, Range 30 West together with Sections 1, 2, 11, 12, 14, 15, 22 and 23 of Township 143 North, Range 30 West, a part of Unorganized Four and Sections 4, 5, 6, 7 and 8 of Township 143 North, Range 29 West, (formerly known as the West Part of Gould Township);

WHEREAS, We, the County Commissioners of said county did, on the 3rd day of March, 1987, proceed to take into consideration, here and determine a certain petition signed (as appears by affidavit) at least twenty-five (25), a majority of all legal voters residing therein (or to be affected hereby), and


WHEREAS, No individual appeared in person or presented any other form of communication objecting to said organization.

NOW, THEREFORE, BE IT RESOLVED: That the Cass County Board of Commissioners do hereby fix the boundaries of the town of Otter Tail Peninsula as described and organize as a new township and to name the same Otter Tail Peninsula Township.

BE IT FURTHER RESOLVED: That the effective date of foregoing organization shall be fixed as of April 1, 1987.

BE IT FURTHER RESOLVED: Pursuant to M.S. 379.05, the County Auditor is instructed to transmit by mail to the Commissioner of Revenue, the Secretary of State, the State Demographer, the Land Management Information Center, the Minnesota Municipal Board and the Commissioner of Transportation an abstract of Board proceeding pertaining to said organization.


