Dear Ms. Larson:

You will recollect our phone conversation a few weeks ago concerning Annexation of certain property upon the Petition from Angela and Cornelius J. VanLith. Mr. & Mrs. VanLith petitioned to the City on August 21, 1985 (copy enclosed) which was accepted by the City Council by Resolution No. R-85-54 at its meeting on September 3, 1985. A copy of the Resolution is also enclosed.

The petitioners pursued their Petition request with the Franklin Township Board and the Board approved the Annexation request and signed a waiver for the ninety (90) days waiting period on December 2, 1985, to be forwarded to the Minnesota Municipal Board. Following the Franklin Township approval, the City Council then adopted the Ordinance No. 0-86-07 (copy enclosed) approving the Annexation.

During our conversation a few weeks ago, you had found that this Annexation Petition and the other documents have not yet been filed in your office. It seems to me somehow the Petitioner did not follow the steps to have this Annexation properly recorded or perhaps they assumed that this was the City's responsibility. Anyhow, I am forwarding all of the above documents to you for taking the proper steps necessary to obtain approval from the Minnesota Municipal Board and inform the petitioner and the City accordingly.

ORDINANCE NO. 0-86-07

AN ORDINANCE EXTENDING THE CORPORATE LEMITS OF THE CITY OF DELANO TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED LAND NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS

WHEREAS, a certain petition dated August 21, 1985, requesting annexation of the territory hereinafter described was duly presented to the council and approved on September 3, 1985; and

WHEREAS, the petition was signed by all owners; and
WHEREAS, the petition was duly served on the Township
on September 3, 1985; and

WHEREAS, no objections to the annexations have been received from the Town Board of Franklin Township or the governing body of any municipality whose boundaries abutt upon the boundaries of the land to be annexed; and

WHEREAS, the Town Board of Franklin Township has adopted a resolution on December 2, 1985 consenting to the annexation by the City of Delano of the territory hereinafter described and waiving the time to make objection; and

WHEREAS, the land described in the petition abutts upon the City limits at the northern and western boundary thereof;

THE COUNCIL OF THE CITY OF DELANO, MINNESOTA, ORDAINS:

SECTION 1. The City Council hereby determines (1) that the territory described herein abutts upon the City limits and is or is about to become urban or suburban in character; and (2) that none of the territory is now included within the limits of any city.

SECTION 2. Territory Annexed. The corporate limits of the city are hereby extended to include the unplatted land described in Exhibit A attached hereto and made a part hereof and the same is hereby annexed to and included within the city as effectually as if it had originally been a part thereof.

SECTION 3. Filing. The City Administrator is hereby directed to file certerfied copies of this ordinance with the Minnesota Municipal Board, the Secretary of State, and the Town Clerk, and the County Auditor.

SECTION 4. Effective Date. This ordinance takes effect upon its passage and publication, and the filing of the certified copies as directed in Section 3, and approval of the ordinance by the Municipal Board.
