
The Minnesota Municipal Board has now processed and approved the above ordinance in accordance with Minnesota Statutes, Chapter 414, and the Rules of Procedure.

The annexation is final upon the date the ordinance is approved by the Board, which is the date of this letter.



AN ORDINANCE TO ANNEX CERTAIN
PROPERTY TO THE CITY OF MANKATO PER
MINNESOTA STATUTES 414.033, SUBDIVISION 3

WHEREAS, certain property described below has been found to not have been included in a previous annexation procedure and is not within the corporate limits of any incorporated city, village, or borough; and

WHEREAS, pursuant to Minnesota Statutes 414.033, Subdivision 3, said property is surrounded by the City of Mankato by eighty-nine (89) percent; and

WHEREAS, said property is part of the Mankato State University campus and has been erroneously considered within the boundary of the City since 1966; and

WHEREAS, on the 10th of November, 1986, the Council of the City of Mankato passed a resolution of intent to annex said property; and

WHEREAS, on the 25th of November, 1986, the Mankato Town Board passed a resolution stating no objection to the annexation of said property:


NOW, THEREFORE, the Council of the City of Mankato hereby ordains that the corporate limits of the City are hereby extended to include the land described as follows and the same is hereby annexed to and included within the corporate limits of the City as effectively as if it had originally been part thereof:

That part of the Southwest Quarter of the Southeast Quarter, Section 19, Township 108 North, Range 26 West described as follows:
beginning at a point on the south line of the Southwest Quarter of the Southeast Quarter of said Section 19, 488.80 feet due east of the Southwest corner of said Southwest Quarter of the Southeast Quarter; thence east 322.30 feet; thence north 24 degrees 47 minutes 53 seconds east, 399.42 feet; thence north 7 degrees 42 minutes 41 seconds east, 188.20 feet; thence north 36 degrees 31 minutes 24 seconds west, 360.80 feet; thence north 15 degrees 33 minutes 12 seconds east, 166.0 feet; thence north 11 degrees 23 minutes 30 seconds west, 205.39 feet; thence due west, 300.0 feet; thence south 0 degrees 16 minutes 18 seconds west and parallel with the west line of the Southwest Quarter of the Southeast Quarter of said Section 19, 1,200.0 feet to the place of beginning. Said tract containing 10.9 acres, more or less.

The City Clerk is hereby directed to file copies of this Ordinance with the Minnesota Municipal Board, the Secretary of State, the Blue Earth County Auditor, and the Mankato Town Board.


This Ordinance shall take effect thirty (30) days after its adoption, due publication thereof, and approval by the Minnesota Municipal Board.

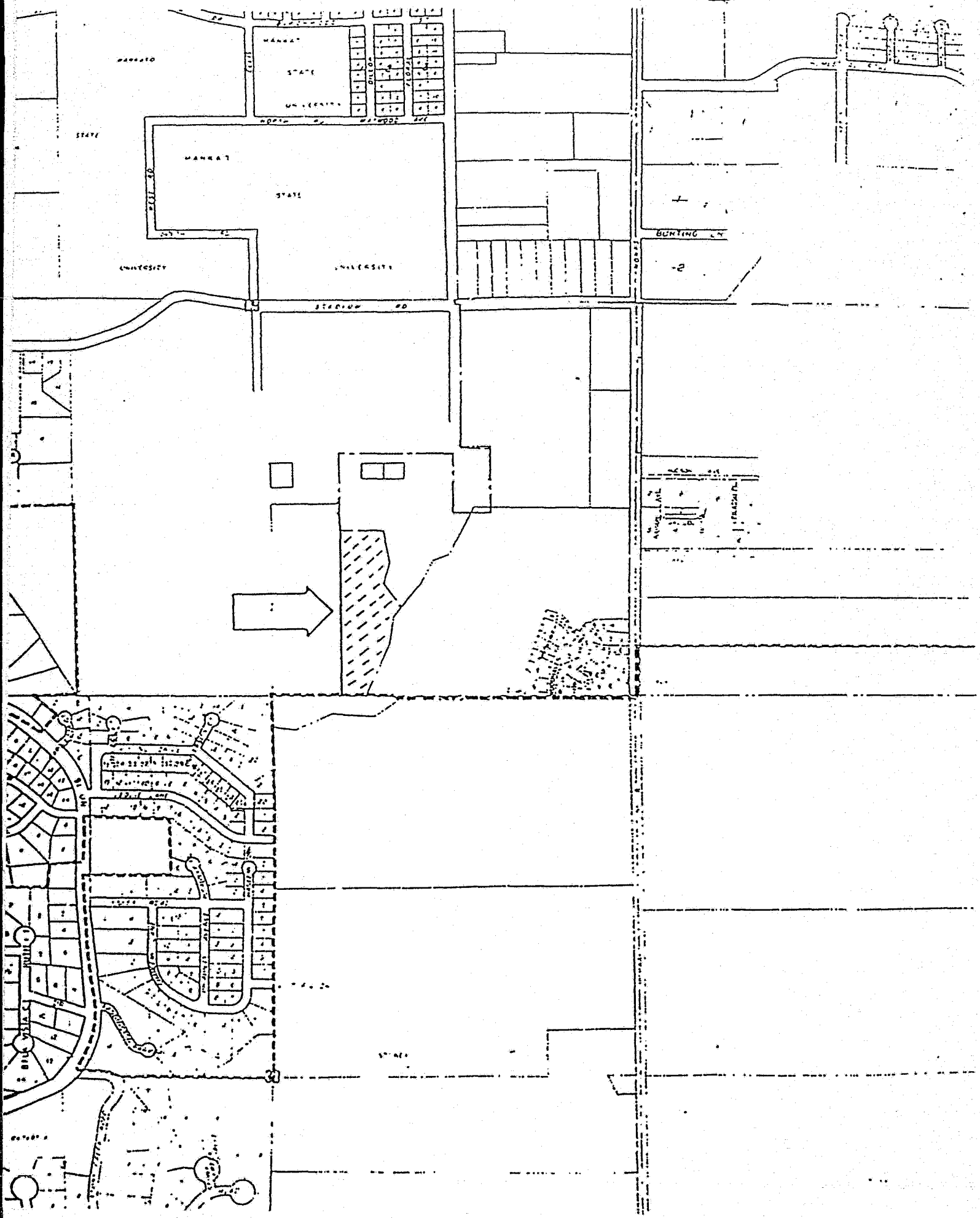
