FOR THE ANNEXATION OF CERTAIN LAND)
TO THE CITY OF ST. CLOUD PURSUANT)
TO MINNESOTA STATUTES 414)

ORDER

WHEREAS, a resolution for the annexation of certain land to the City of St. Cloud was filed with the Minnesota Municipal Board on December 3, 1985; and

WHEREAS, amended resolutions were received on January 7, 1986 and January 30, 1986; and

WHEREAS, a hearing was convened on said resolution for the annexation of certain land to the City of St. Cloud on March 12, 1986 and was continued from time to time; and

WHEREAS, the parties have requested that the above-referenced Petition/Resolution be dismissed without prejudice;

IT IS HEREBY ORDERED: That the above-entitled Resolution/Petition is hereby dismissed without prejudice. The property description in said Petition/Resolution is described as follows:

All that part of said Township that lies northerly and westerly of the thread of the Sauk River LESS AND EXCEPT that portion thereof that lies within the present corporate limits of the City of St. Cloud.

Together with that part of said Township that lies southerly of the present corporate limits of the City of St. Cloud, easterly of the

centerline of Minnesota State Trunk Highway No. 15, and westerly of the easterly right-of-way line of Stearns County Road No. 75 (formerly known as Minnesota State Trunk Highway No. 152), LESS AND EXCEPT the Southwest Quarter (SW 1/4) of Section 27, the Southeast and Southwest Quarters (SE 1/4) and (SW 1/4) of Section 28, all of Section 33, the Northwest, Southwest and Southeast Quarter (NW 1/4), (SW 1/4) and (SE 1/4) of Section 34, and that part of Section 32 and the Southeast Quarter (SE 1/4) of Section 29 that lie easterly of the centerline of Minnesota State Trunk Highway No. 15.

And together with that part of said Township described as follows, to-wit: That part of the Northeast Quarter of the Southwest Quarter (NE 1/4 of SW 1/4) of Section 21 that lies northerly and westerly of the centerline of Minnesota State Trunk Highway No. 15.

IT IS FURTHER ORDERED: That the effective date of this order is May 28, 1987.
