ORDER

WHEREAS, a joint resolution for orderly annexation was adopted by the City of St. Joseph and the Town of St. Joseph and duly accepted by the Minnesota Municipal Board; and

WHEREAS, a resolution was received from the City of St. Joseph and the Town of St. Joseph indicating their desire that certain property be immediately annexed to the City of St. Joseph pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 requires that the Minnesota Municipal Board review and comment, but within 30 days approve the annexation of land pursuant to said subdivision; and

WHEREAS, on May 29, 1987, the Minnesota Municipal Board has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of St. Joseph, Minnesota, the same as if it had originally been made a part thereof:

Part of Section 10, Township 124N, Range 29W, Stearns County, Minnesota, being at the place where State Aid Road #2, meets old State Aid #2, such point being the North Boundary line of the herein described tract, with the East boundary line going South along the boundary line of Old State Aid Road #2, a distance of 595 feet, thence at right angles to the West a distance of 360 feet to the East boundary line of State Aid Road Number 2, thence Northeasterly along said boundary of State Aid #2 to the place where State Aid Road #2 meets Old State Aid Road #2, the north boundary line being a distance of 80 feet. 3.00 acres, plus or minus, all in Stearns County, Minnesota.

IT IS FURTHER ORDERED: That the effective date of this order is May 29, 1987.
