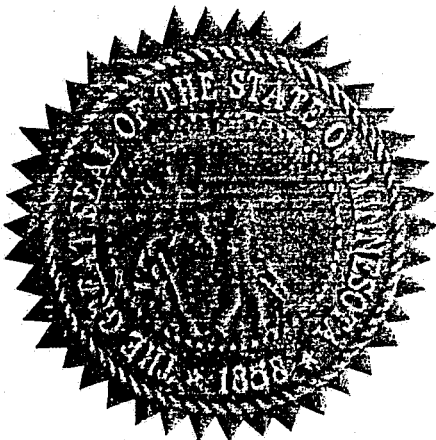

RESOLVED, That the Board of Ramsey County Commissioners hereby organizes a regional railroad authority, pursuant to Minnesota Statutes Chapter 398A, to be known as the Ramsey County Regional Railroad Authority ("Authority");

- a) That this authority is organized under the regional railroad authorities act as a political subdivision and local government unit of Minnesota, to exercise thereunder part of the sovereign power of the state;
- b) That this Authority shall be known as the Ramsey County Regional Railroad Authority;
- c) That the governing body adopting this organization resolution is the Board of Ramsey County Commissioners;
- d) That this Authority shall be governed by a board of seven commissioners; that said commissioners shall be appointed by the Board of Ramsey County Commissioners; that the names and addresses of the members of the first board of commissioners are as follows:

  6. Warren Schaber, 316 Court House, 15 W. Kellogg Blvd., St. Paul, MN. 55102

- e) That the registered office of this Authority shall be situated in St. Paul, County of Ramsey, Minnesota;
- f) That neither the State of Minnesota, the County of Ramsey, nor any other political subdivision is liable for obligations of the authority;
- g) That there will be an appropriate citizen participation component, including municipalities, in the railroad authority process and the staff is directed to develop such a process, circulate the proposed process for review and comment, and present the process for consideration and approval by the County Board.
