ORDER

WHEREAS, a joint resolution for orderly annexation was adopted by the City of St. Cloud and the the Town of St. Cloud and duly accepted by the Minnesota Municipal Board; and

WHEREAS, a resolution was received from the City of St. Cloud and the Town of St. Cloud indicating their desire that certain property be immediately annexed to the City of St. Cloud pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 requires that the Minnesota Municipal Board review and comment, but within 30 days approve the annexation of land pursuant to said subdivision; and

WHEREAS, on June 8, 1987, the Minnesota Municipal Board has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of St. Cloud, Minnesota, the same as if it had originally been made a part thereof:

Lots Two (2), Three (3), Four (4) and Five (5) in Block Three (3), and Lots Ten (10), Eleven (11), Twelve (12), Thirteen (13), Fourteen (14), Fifteen (15) and Sixteen (16), in Block One (1), Holy Spirit Addition, Stearns County, Minnesota.

IT IS FURTHER ORDERED: That the effective date of this order is June 8, 1987.
