Amendment #1

That Chapter 10 of the City Charter, as amended heretofore, be further amended by striking out the entire chapter and substituting in lieu ### thereof a chapter to read as follows:

Section 1. The City assessor shall be appointed each numbered Year for a term of two years, and shall # qualify and perform the duties as pre# spribed by law relative thereto, and shall list and prepare a schedule and chart of all assessable real ### property of the city, showing the valuation and condition of all such property, and designate the names of the owners thereof. He shall keep## such record by a card system to be approved by the City Council and shall prepare# such other records and reports pertaining thereto, as the city council may from time to time require, all of such records, so compiled by him, shall be the property of the city. The city Council shall designate and furnish office space for said Assessor, a suitable fireppoof repository for all his records, and such supplies as in their opinion may be necessary to carry on his work.

Sec 2. The city Council, if they deem it necessary, may appoint a Deputy Assessor and Assistants to aid ## the Assessor and Board of Equalization. The City Council shall determine the term### for which said Deputy assessor and Assistants shall be employed and their Compensation. The Assesor, and Assistants and Deputy Assessor shall qualify scoording to Law before entering upon the duties of their Office.

Sec. 3. The Compensation of the City Assessor, Deputy Assessor, and Assistants shall be fixed by the City Council.

Sec. 4. The Board of Equalization shall consist of a City Clerk and one Alderman from each Ward to be chosen by the City Council, Who shall be sworn# according to law as such board, shall select one of their number to act as Chairman, and shall meet at the City Council chamber on the fourth Monday in June in each year, and shall continue in session until the Friday next preceding the first Monday in July to review, and amend and equalize the work of the city assessor, pursuant to the general laws of the State, Such board of Equalization shall receive as Compensation for their services the sum of (\$5.00) dollars per day for each member for the actual time employed, It shall be the duty of the City Assessor to attend all meetings of the board of Equalization, and the city clerk shall keep the minutes of their Proceedings.

Sec. 5. Such board shall be vested with all the powers which are or may be vested in County boards of Equalizations far as applicable, but shall not be restricted in reducing the aggregate sum of the real or personal Property as returned by the Assessor, and when its work of revision is completed the same shall be certified to the County Auditor by the board of Equalization.

Sec.6. Any person deeming himself aggrieved by any assessment may appear before such board personally or by council and present his grievance for consideration, and the said board shall have powerto compel the attendance of witnesses and the production of papers, and examine any person as to any taxable property in said City.
