REORGANIZATION ORDER NO. 146

Pursuant to Minnesota Statutes 1986, Section 16B.37, the following administrative reorganization is made with the prior approval of the Governor.

In order to improve efficiency, avoid duplication in the operation of state government, and carry out the provisions of Laws 1987, Chapter 332, the following positions and their incumbents are transferred, with all accrued benefits, from the Department of Labor and Industry to the Department of Employee Relations:

Three additional special revenue positions, authorized by Laws 1987, Chapter 404, Section 32, but not yet established, shall be transferred from the Department of Labor and Industry to the Department of Employee Relations.

The special revenue complement of the Department of Labor and Industry, as provided in Laws 1987, Chapter 404, Section 32, is decreased by 32 positions; the special revenue complement of the Department of Employee Relations, as provided in Laws 1987, Chapter 404, Section 19, is increased by 32 positions.


By January 1, 1988 the Department of Employee Relations and Department of Labor and Industry shall analyze the support service needs of the State Claims Unit to determine whether to transfer an additional support position to the Department of Employee Relations. The analysis shall consider the overall support service needs of both departments. The position shall be transferred upon the approval of the Commissioner of Administration.

The duties of the Department of Labor and Industry to administer the state compensation revolving fund, as provided in Laws 1987, Chapter 404, Sections 151 and 152, are transferred to the Department of Employee Relations. The state's membership in the Workers' Compensation Reinsurance Association is transferred from the Commissioner of Labor and Industry to the Commissioner of Employee Relations.


The Commissioner of Finance shall make the necessary financial determinations in accordance with Minnesota Statutes 1986, Section 16B.37, Subdivision 3.


