Re: Chisago Lakes Hospital Annexation (MMB Docket No. A-4343)

I am enclosing a copy of our City Ordinance #152 which extends our corporate limits to include Chisago Lakes Hospital. According to Chapter 414 of the Minnesota Statutes and the Rules of Proceedure of the Minnesota Municipal Board, I am to file a copy with your office.

A copy of the ordinance has also been recorded with the office of the Recorder of Chisago County.

ORDINANCE NO. 152

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF CHISAGO CITY TO INCLUDE CERTAIN UNINCORPORATED UNPLATTED TERRITORY NOT EXCEEDING 200 ACRES IN AREA ABUTTING UPON THE CITY LIMITS.

WHEREAS, a certain petition dated September 22, 1986, requesting annexation of the territory described in Exhibit A attached was duly filed with the City Clerk on September 22, 1986; and

WHEREAS, the petition was signed by all owners of the territory described in the petition; and

WHEREAS, a resolution of waiver of objection to annexation was adopted by the Town Board of Chisago Lakes Township on October 21, 1986; and

WHEREAS, the territory described in the petition abuts upon the City limits at the North boundary thereof;

The Council of the City of Chisago City, Minnesota, ordains:

Section 1. The Council hereby determines (1) that the territory described in the petition abuts upon the City limits and is or is about to become urban or suburban in character; and (2) that none of the territory is now included within the corporate limits of any incorporated city.

Section 2. The corporate limits of the City of Chisago City are hereby extended to include the unplatted territory described in Exhibit A attached and the same is hereby annexed to and included within the City as effectually as if it had originally been a part thereof.

Section 3. The City Clerk is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Board, the Secretary of State of the State of Minnesota, the Town Clerk of Chisago Lakes Township, and the County Auditor of Chisago County.

Section 4. This ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section 3, and approval of the ordinance by the Minnesota Municipal Board pursuant to Minn. Stat. §414.033(7).

That part of Government Lot 6, Section 32, Township 34 North, Range 20 West, Chisago County, Minnesota, described as follows:

Commencing at the point of intersection of the south line of said Government Lot 6 with the extension northerly of the westerly line of Oak Street as dedicated on the recorded plat of A. W. Carlson's Rearrangement of Lots 1 to 13 Inclusive, of Chisago Beach, Chisago County, Minnesota; thence North 7 degrees 37 minutes East, 499.22 feet; thence South 67 degrees 36 minutes East, 25.85 feet to the point of beginning of the parcel to be described; thence continuing South 67 degrees 36 minutes East, 82 feet, more or less, to a line 50 feet westerly of when measured at right angles to a line hereinafter described as "Line A"; thence northeasterly, parallel with said "Line A", 410 feet, more or less, to the northerly line of a 14 foot strip of land described as being an overrun in said Government Lot 6 in a Affidavit recorded in Book R of Miscellaneous on page 249 in the Chisago County Recorder's Office; thence westerly, along said northerly line, to the easterly right-of-way line of Lake Boulevard (also known as Trunk Highway No. 8); thence southerly, along said easterly right-of-way line, to the south line of said Government Lot 6; thence easterly, along said south line, to the point of commencement; thence North 7 degrees 37 minutes East, 277.45 feet to the north line of the South 275 feet of said Government Lot 6; thence easterly, along said north line, 25.22 feet to its intersection with a line that bears South 7 degrees 37 minutes West from the point of beginning; thence North 7 degrees 37 minutes East, 211.8 feet, more or less, to the point of beginning.

The above referred to "Line A" is described as follows:

Beginning at the above described point of commencement; thence North 25 degrees 44 minutes East, 509 feet; thence North 19 degrees 54 minutes East, 404.64 feet and said "Line A" there terminating.
