In your letter of April 9, 1987, you informed me that the Minnesota Municipal Board had approved Ordinance #0-86-07, authorizing annexation of Mr. C.J. Van Lith's property. However, in your letter of March 20, 1987, you had indicated some discrepancies in the legal description of the above mentioned property and had asked the City to make certain corrections and file the revised and correct legal description of the property. 

CITY OF DELANO WRIGHT COUNTY, MINNESOTA

AN ORDINANCE AMENDING ORDINANCE NO. 0-86-07 BY CORRECTING THE LEGAL DESCRIPTION ATTACHED AS EXHIBIT "A" TO ORDINANCE NO. 0-86-07

WHEREAS, Ordinance No. 0-86-07 ws adopted by the City Council on April 15, 1986, which Ordinance annexed certain property described on Exhibit "A" thereto.

WHEREAS, the legal description contained certain ambiguities and omitted certain highway property intended to be annexed.

THE CITY COUNCIL OF THE CITY OF DELANO, MINNESOTA, ORDAINS:

Section 1. Ordinance No. 0-86-07 is hereby amended by deleting Exhibit "A" thereto and inserting in its place the legal description attached hereto as Exhibit "1".

•<u>Section 2</u>. Except as hereby amended, Ordinance No. 0-86-07 remains in full force and effect.

Section 3. This Ordinance takes effect upon its passage and publication, and the filing of the certified copies as directed in Section 3, of Ordinance No. 0-86-07, and approval of Ordinance No. 0-86-07 and this Ordinance by the Municipal Board.
