STATE OF MINNESOTA DEPARTMENT OF ADMINISTRATION REORGANIZATION ORDER NO. 148

Pursuant to Minnesota Statutes 1986, Section 16B.37, the following administrative reorganization is made with the prior approval of the Governor.

In order to improve efficiency, avoid duplication in the operation of state government, and implement the provisions of Minnesota Laws 1987, Chapter 352, the Department of Human Services' duties for client advocacy in the state's Regional Treatment Centers are transferred to the Ombudsman for Mental Health and Mental Retardation.

Consistent with this transfer of duties, the following positions and their incumbents, with all accrued benefits, are transferred from the Department of Human Services to the Ombudsman for Mental Health and Mental Retardation:

The complement of the Ombudsman for Mental Health and Mental Retardation is increased by ten positions; the complement of the Department of Human Services is decreased by ten positions.

The Department of Human Services shall give to the Ombudsman for Mental Health and Mental Retardation all contracts, books, maps, plans, papers, records and equipment relating to the transferred duties.

Any proceeding, court action, prosecution, or other business or matter pending on the effective date of the transfer may be conducted and completed by the Ombudsman for Mental Health and Mental Retardation in the same manner under the same terms and conditions, and with the same effect, as though it involved or were commenced and conducted or completed prior to the transfer by the Department of Human Services.

The Commissioner of Finance shall make the necessary financial determinations in accordance with Minnesota Statutes 1986, Section 16B.37, Subdivision 3.

The Minnesota State Council on Disability shall carry out the duties of the Ombudsman for Mental Health and Mental Retardation as specified in Laws 1987, Chapter 352, and this reorganization order until an Ombudsman is appointed by the Governor.

The effective date of this order is July 15, 1987. The order is herewith filed with the Secretary of State and shall remain in effect until amended or repealed.
