



AGREEMENT BETWEEN THE CITY OF AUSTIN )	
AND THE TOWN OF AUSTIN PURSUANT TO )	<u>ORDER</u>
MINNESOTA STATUTES 414 )

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Austin and the Town of Austin and duly accepted by the Minnesota Municipal Board; and

WHEREAS, a resolution was received from the City of Austin indicating their desire that certain property be annexed to the City of Austin pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 requires that the Minnesota Municipal Board review and comment, but within 30 days approve the annexation of land pursuant to said subdivision; and

WHEREAS, on August 6, 1987, the Minnesota Municipal Board has reviewed and approved the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Austin, Minnesota, the same as if it had originally been made a part thereof:

That portion of Lots Two and Three, both in Block 3, Austin Homesteads in Section 9, Township 102 North, Range 18 West, Mower County, Minnesota, more specifically described as follows: Beginning at a point 263.36 feet West and 17.15 feet South of the Northeast corner of said Lot 3; thence North a distance of 100 feet; thence West to the point at which said line extended West intersects the center of Fairhaven Drive in said Austin Homesteads; thence generally

southerly along the center of said Fairhaven Drive to a point thereon at which the northern boundary line of said Lot 3, extended West intersects the center of said Fairhaven Drive; thence South a distance of 17.15 feet; thence East a distance of 179.06 feet, more or less, to the place of beginning.

IT IS FURTHER ORDERED: That the effective date of this order is August 6 1987.
