## ORDINANCE NO. 86-9-15-3.

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF LONG PRAIRIE TO INCLUDE CERTAIN UNINCORPORATED TERRITORY BORDERED BY LAND WITHIN THE CITY LIMITS AND ABUTTING THEREON

WHEREAS, A certain territory described below is not presently included within the corporate limits of any incorporated city, or borough; and,

WHEREAS, the perimeter of this territory is bordered by lands already included within the corporate limits of the city and is deemed to be urban or suburban in character;

WHEREAS, the area to be annexed does not exceed 200 acres; and,

WHEREAS, the owners of the area to be annexed have petitioned the city council for annexation;

NOW THEREFORE THE CITY COUNCIL OF LONG PRAIRIE ORDAINS:

Section 1. Territory annexed. The corporate limits of the City of Long Prairie, Minnesota, are hereby extended to include the unplatted territory described as follows:

That part of the Northwest Quarter of the Northeast Quarter (NW1/4NE1/4) and that part of Government Lot Two (2), all in Section 29, Township 129 North, Range 33 West of the 5th Principal Meridian, described as follows: Commence at the northwesterly most corner of Lot 1, Block One, KENDON 1ST ADDITION, Todd County, Minnesota; thence on a record bearing of South 86°21'27" East and along the North line of said Lot One (1) a distance of 235.31 feet to the northeast corner of said Lot One (1) and this to be the point of beginning; thence South 89°17'00" East 200.00 feet; thence South 00°43'00" West 508.00 feet; thence South 89°17'00" East 200.00 feet; thence south  $00^{\circ}43'00"$  west 559.65 feet; thence south  $46^{\circ}46'33"$ east 138.87 feet to a point on the center line of the existing county road, said point being on a 531.24 foot radius curve which the center of circle bears South 39°38'21" east from said point; thence southwesterly along said curve and said center line central angle 07°08'12" 66.17 feet; thence South 43°13'27" west along said center line 60.41 feet; thence southwesterly along said center line and a tangential curve concave to the Southeast, radius 1136.73 feet, delta angle 17°59'47" 357.11 feet; thence south 25°13'40" west along said center line 200.25 feet; thence Southwesterly along said center line and a tangential curve concave to the northwest, radius 292.44 feet, central angle 38°45'29" 197.84 feet to the southeasterly most corner of said plat of KENDON 1ST ADDITION; thence North

00°43'00" East and along the east line of said plat of KENDON IST ADDITION 1870.42 feet to the point of beginning and containing 12.47 acres, subject to existing right-of-way easement to the Northern Natural Gas Company.

Section 2. Filing. The City Administrator/Clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the County in which the property is located, the Town Clerk of the affected township and the Minnesota Municipal Board.

Section 3. Effective date of annexation. This ordinance takes effect upon passage and publication and the filing of certified copies as directed in Section 2 and approval by the Minnesota Municipal Board.
