MINNESOTA STATUTES 414

ORDER

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Northfield and the Town of Northfield and duly accepted by the Minnesota Municipal Board; and

WHEREAS, a resolution was received from the City of Northfield and the Town of Northfield indicating their desire that certain property be annexed to the City of Northfield pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on October 9, 1987, the Minnesota Municipal Board has reviewed and approved the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Northfield, Minnesota, the same as if it had originally been made a part thereof:

The West 300 feet of the Southeast Quarter (SE1/4) of Northwest Quarter (NW1/4), and the West 300 feet of the Northeast Quarter (NE1/4) of Southwest Quarter (SW1/4) lying northerly of County State Aid Highway 28, all in Section 5, Township 111 North, Range 19 West, Rice County, Minnesota.

IT IS FURTHER ORDERED: That the mill levy of the City of Northfield on the property herein ordered annexed shall be increased in substantially equal proportions over a period of three years to equality with the mill levy of the property already within the city.

IT IS FURTHER ORDERED: That the effective date of this order is October 9, 1987.
