MINNESOTA STATUTES 414

ORDER

WHEREAS, a joint resolution for orderly annexation was adopted by the City of St. Joseph and the Town of St. Joseph and duly accepted by the Minnesota Municipal Board; and

WHEREAS, a resolution was received from the City of St. Joseph and the Town of St. Joseph indicating their desire that certain property be immediately annexed to the City of St. Joseph pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on October 9, 1987, the Minnesota Municipal Board has reviewed and approved the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of St. Joseph, Minnesota, the same as if it had originally been made a part thereof:

All that part of the Northeast Quarter of the Southwest Quarter (NE 1/4 SW 1/4) and of the Southeast Quarter of the Northwest Quarter (SE 1/4 NW 1/4) of Section Ten (10), Township One Hundred Twenty-four (124) North, of Range Twenty-nine (29) West, Stearns County, Minnesota, described as follow: Beginning at the point of

intersection of the East line of said tract and the South line of Spruce Street of the Village of St. Joseph extended easterly, thence westerly along the South line of Spruce Street extended, to the East line of Woodrow Wilson Street; thence Southerly along the East line of Woodrow Wilson Street a distance of approximately 140 feet, to the North line of the tract conveyed in the deed recorded in the office of the Register of Deeds of Stearns County, in book 305 of deeds on page 560; thence Easterly and parallel to the South line of Spruce Street extended to the east line of NE 1/4 SW 1/4 of Sec. 10; thence northerly along the east line of NE 1/4 SW 1/4 of Section 10 to the point of beginning.

IT IS FURTHER ORDERED: That the effective date of this order is October 9, 1987.
