Affidavit of Publication

STATE OF MINNESOTA,

W. J. Baker being duly sworn, deposes and says that he now is and during all the times hereinafter mentioned has been the manager or printer in charge of the LeSueur Center Leader, a weekly newspaper, printed and published in the Village of LeSueur Center, in said LeSueur County, State of Minnesota, on Thursday of each week;

- (4) Circulated in and near its place of publication to the extent of at least two hundred and forty copies regularly delivered to paying subscribers, and that prior to the date of the first publication of said notice the manager or printer in charge of said newspaper having knowledge of the facts, filed in the office of the county auditor of said county of LeSueur, state of Minnesota, an affidavit showing the name and location of said newspaper and the existence of conditions constituting its qualifications as a legal newspaper as required and set forth in section 3 of chapter 484, Session Laws Minnesota, 1921.

ORDINANCE NO. 44.
An ordinance to extend the village boundaries.
The Village Council of the Village of LeSueur Center, Minnesota, do ordain as follows:
Sec. 1. WHEREAS, this village has heretofore acquired that certain tract of land which is hereinafter described, for a public tourist camping ground, which said tract is not located within but adjoins the village limits, and it is deemed expedient and desirable that the boundaries of the village should be extended so as to include the said tract of land;
Sec. 2. The village limits are hereby extended so as to include the said tract, viz: The west 500 ft. of the east 1004.3 ft. of the north 880 ft. of the north half of the northeast quarter of section numbered thirty-two, township numbered one hundred and eleven, range numbered twenty-four.
Sec. 3. This ordinance shall take effect and be in force from and after its publication.
