The Commission of Administration and Finance.

You are advised that the supreme court, by decision filed this day, has reversed the judgment of the district court of Ramsey county in effect sustaining the governor's veto of the bill passed at the recent session of the legislature increasing the salary of the judges of the district court. The supreme court holds that the veto was without effect because the bill with the veto message was not returned to the house in which it originated within three days after it was delivered to the governor for his consideration.

As a result of the decision the measure took effect as a law of the state, notwithstanding the governor's objections.

The supreme court remands the cause to the district court for the entry of judgment, in effect directing that this act be included in the publication of laws enacted at the 1937 legislative session. Accordingly, this act should be give an appropriate chapter number and included in the publication.
