ORDINANCE ANNEXING TERRITORY TO THE CITY OF MONTEVIDEO

THE CITY OF MONTEVIDEO DOES ORDAIN:

1. The City Council of the City of Montevideo finds as

facts:

1.1. The City of Montevideo is the owner of the following tract of land in the County of Chippewa and State of Minnesota:

The North Thirty-three Feet (N 33') of the East Half of the Northeast Quarter of the Southwest Quarter (E $\frac{1}{2}$ of NE $\frac{1}{4}$ of SW $\frac{1}{4}$) of Section Eight (8), Township One Hundred Seventeen (117) North, Range Forty (40) West; and

The South Thirty-three Feet (S 33') of the East Half of the Southeast Quarter of the Northwest Quarter (E $\frac{1}{2}$ of SE $\frac{1}{4}$ of NW $\frac{1}{4}$) of Section Eight (8), Township One Hundred Seventeen (117) North, Range Forty (40) West; and

The North Thirty-three Feet (N 33') of the West Half of the Northeast Quarter of the Southwest Quarter (W $\frac{1}{2}$ of NE $\frac{1}{4}$ of SW $\frac{1}{4}$) lying east of an extension northerly of the easterly line of Thirteenth Street as formerly platted in the City of Montevideo and all lying within Section Eight (8), Township One Hundred Seventeen (117) North, Range Forty (40) West; and

The South Thirty-three Feet (S 33') of the West Half of the Southeast Quarter of the Northwest Quarter (W $\frac{1}{2}$ of SE $\frac{1}{4}$ of NW $\frac{1}{4}$) of Section Eight (8), Township One Hundred Seventeen (117) North, Range Forty (40) West, except the Westerly Six Hundred Feet (600') thereof.

1.2. That said premises are urban or suburban in character or are about to become so.

1.3. That the said tract of land borders on the City of Montevideo at its easterly boundary.

1.4. The annexation of said premises to the City of Montevideo is in the best interests of the City of Montevideo and of the territory to be annexed.

2. Pursuant to Minnesota Statute § 414.033, Subd. 2, that certain tract of land in the County of Chippewa and State of Minnesota described as follows:

The North Thirty-three Feet (N 33') of the East Half of the Northeast Quarter of the Southwest Quarter (E½ of NE¼ of SW¼) of Section Eight (8), Township One Hundred Seventeen (117) North, Range Forty (40) West; and

The South Thirty-three Feet (S 33') of the East Half of the Southeast Quarter of the Northwest Quarter (E½ of SE¼ of NW¼) of Section Eight (8), Township One Hundred Seventeen (117) North, Range Forty (40) West; and

The North Thirty-three Feet (N 33') of the West Half of the Northeast Quarter of the Southwest Quarter (W½ of NE¼ of SW¼) lying east of an extension northerly of the easterly line of Thirteenth Street as formerly platted in the City of Montevideo and all lying within Section Eight (8), Township One Hundred Seventeen (117) North, Range Forty (40) West; and

The South Thirty-three Feet (S 33') of the West Half of the Southeast Quarter of the Northwest Quarter (W½ of SE¼ of NW¼) of Section Eight (8), Township One Hundred Seventeen (117) North, Range Forty (40) West, except the Westerly Six Hundred Feet (600') thereof.

is hereby annexed to the City of Montevideo and is incorporated into the corporate limits of the City.

3. The City Clerk of the City of Montevideo is hereby directed to file a copy of this Ordinance with the State of Minnesota Municipal Board, Sparta Township, the Chippewa County Auditor, and the Secretary of State of the State of Minnesota.

4. This Ordinance shall take effect thirty (30) days after its passage and publication and upon its approval by the Minnesota Municipal Board.
