ORDER  
CORRECTING  
ORDER

A sufficient petition having been filed with the former Minnesota Water Resources Board (WRB) pursuant to Minnesota Statutes Section 473.8771 (1986) seeking certain changes in the boundary of the Coon Creek Watershed District (District); proper notice of filing of the petition having been given by the WRB; the WRB having adopted Findings of Fact, Conclusions of Law, and an Order on September 21, 1987 making the boundary changes proposed in the petition; the Board of Water and Soil Resources (Board) having received a letter from Mr. Charles R. Lefebvre, Anoka County Auditor, on October 23, 1987 that pointed out certain errors in the legal descriptions of the WRB's September 21, 1987 Order; and Board staff having contacted the Anoka County Auditor's Office to double check the accuracy of the Auditor's suggested corrections; the Board makes the following:


ORDER CORRECTING ORDER

1. Paragraph 6 of the Findings of Fact of the former WRB's Order dated September 21, 1987, which described certain lands excluded from the Coon Creek Watershed District, is amended to correct errors in the property descriptions as follows:

- a. In the last seven lines on page 3, change the fourth identifier in each of the five parcel identification numbers listed from "31" to "42"; and
  - b. In the tenth line on page 5, insert "Block 4," before "Woodland Terrace"; and
  - c. Strike lines eleven and twelve on page 5, and insert the following: "the east lines of Lots 9 through 1, Block 4, Woodland Terrace, and Lots 7 through 10, Block 1, Woodland Terrace 2nd Addition, extended to the south line of the".
2. The boundary of the Coon Creek Watershed District is defined by the former Water Resources Board's Order dated December 3, 1959, which originally established the District's boundary; as modified by boundary change Orders dated February 21, 1964; July 13, 1967; March 8, 1985; December 12, 1986; April 10, 1987; and September 21, 1987 as corrected by this Order.
