ORDINANCE NO. 53, 2ND SERIES
AN ORDINANCE ANNEXING CERTAIN PARCELS OF LAND TO THE CITY OF INTERNATIONAL FALLS AND PLACING THE SAME WITHIN THE JURISDICTION OF SAID CITY.

THE CITY COUNCIL OF THE CITY OF INTERNATIONAL FALLS, MINNESOTA DOES ORDAIN AS FOLLOWS:

Section 1. That the following parcels of land described in Section 2 have been petitioned for annexation by the city of International Falls by all of the landowners.

Section 2. That after due consideration, the City Council has deemed it to be in the best interest of the City that said land be annexed to and become a part of said city, said property being described as follows:
A. PARCEL ONE A: Government Lots $1,2,3$ and that part of 4 lying in the Northwest Quarter of the Northwest Quarter (NW $\frac{1}{2}$ - NW? ) of Section Thirty-five, Township Seventy-one North; Range Twenty-four west (Sec. $35, \mathrm{~T}-71-\mathrm{N}, \mathrm{R}-24-\mathrm{W}$ ) containing approximately 89.53 acres.

Section 5. This Ordinance will supersede and replace Ordinance No. 44, 2nd Series, passed July 13, 1987.

Section 6. After adoption, signing and attestation, this Ordinance shall be published once in the official newspaper of the City and shall be in effect on and after the day following such publication.
