



O R D E R

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Victoria and the Town of Laketown and duly accepted by the Minnesota Municipal Board; and

WHEREAS, a resolution was received from the City of Victoria and the Town of Laketown indicating their desire that certain property be annexed to the City of Victoria pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on March 1, 1988, the Minnesota Municipal Board has reviewed and approved the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Victoria, Minnesota, the same as if it had originally been made a part thereof:

The Northeast Quarter (NE1/4) of Section 23, Township 116 North, Range 24 West. Also, all of that part of the Northwest Quarter

(NW1/4) of Section 24, Township 116 North, Range 24 West, lying westerly and southwesterly of the Centerline of Carver County State Aid Highway No. 11.

IT IS FURTHER ORDERED: That the effective date of this order is March 1, 1988.
