ORDINANCE NO. 106

ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF LAKE PARK, MINNESOTA, TO INCLUDE CERTAIN UNINCORPORATED TERRITORY ABUTTING THE CITY LIMITS AND OWNED BY THE CITY

WHEREAS, Council finds that the East 300 feet of the NE¹/₄ of Section 4, Township 139 North, Range 43 West of the 5th P.M. in Becker County, Minnesota, is owned by the City of Lake Park, and abuts on the existing city limits of the City of Lake Park, and

WHEREAS, the said tract is not presently included within the corporate limits of any incorporated city or borough, and

WHEREAS, the land is deemed to be urban or suburban in character.

THE CITY OF LAKE PARK DOES ORDAIN:

Section 1. The corporate limits of the City of Lake Park, Minnesota, are hereby extended to include the unplatted property described as follows, which tract is owned by the city.

The East 300 feet of the NE¼ of Section 4, Township 139 North, Range 43 West in Becker County, Minnesota.

Section 2. The city clerk is directed to file certified copies of this ordinance with the Minnesota Municipal Board, the Township of Lake Park, Auditor of Becker County, Minnesota, and the Secretary of State of the State of Minnesota.

Section 3. This ordinance takes effect upon passage and publication and filing of the certified copies as set forth in Section 2 and upon approval by the Minnesota Municipal Board.


