IT IS HEREBY ORDERED: That the above-entitled petition is withdrawn and the Minnesota Municipal Board file on said petition is hereby closed. The property description in said petition is described as follows:

> That part of the South 548.50 feet, as measured at right angles, of the Northeast Quarter of the Southwest Quarter (NE1/4 of SW1/4) of Section 20, Township 33, Range 27, Sherburne County, Minnesota, lying west of the West line of the East 462.00 feet (28 rods), as measured at right angles, thereof. Subject to that part thereof taken for right-of-way of U.S. Highways No. 10 and 52. Containing 7.61 acres,

more or less, exclusive of said highway right-of-way. Also subject to that part taken for County Road No. 43 over and across the West 33.00 feet thereof.

IT IS FURTHER ORDERED: That the continued hearing scheduled for June 23, 1988 is hereby cancelled.
