ORDINANCE NO. 99
AN ORDINANCE ANNEXING CERTAIN LAND TO THE CITY
OF HOLDINGFORD, IN STEARNS COUNTY, MINNESOTA

WHEREAS a certain Petition was duly filed with the City Council in and for the City of Holdingford, in Stearns County, Minnesota, by the majority of property owners in number of certain land lying within the Township of Holding in Stearns County, Minnesota and legally described as follows: All of Lots 30, 31, 32, 33, 34, 35 and 36, of Auditor's Subdivision 13, Township of Holding, according to the plat and survey thereof on file and of record in the office of the Register of Deeds in and for Stearns County, Minnesota, petitioning that said real estate be annexed to the City of Holdingford, Minnesota, and,

WHEREAS it was determined by the City Council that the property owners who signed the Petition were the majority of property owners in number of said land, that the property is platted, or is unplatted and does not exceed 200 acres, and that the land abuts upon the boundaries of the City of Holdingford, and,

WHEREAS, upon receipt of said Petition said City Council filed copies of the same with the Minnesota Municipal Board, the Township Board of Holding and the Stearns County Board, and within 90 days of filing there were no written objections to the annexation submitted to the City of Holdingford and the Minnesota Municipal Board, and,

WHEREAS, the City of Holdingford gave at least 30 days mailed notice of a public hearing to affected property owners, and

WHEREAS, the City of Holdingford conducted a public hearing on the annexation on May 9, 1988, and


WHEREAS the Holdingford City Council has determined that the property proposed for the annexation is now or is about to become urban or suburban in character,

NOW THEREFORE the City Council in and for the City of Holdingford does hereby declare and ordain: That the corporate limits of the City of Holdingford, in Stearns County, Minnesota, be and they hereby are extended to include that certain real estate hereinbefore described and the same is hereby annexed and included in the City of Holdingford as effectually as if it had originally been a part thereof.


It is further ordained that the Holdingford City Clerk file certified copies with the Minnesota Municipal Board, Holding Township, the Stearns County Auditor and the Secretary of the State of Minnesota.

This ordinance shall become effective and is final on the date the ordinance is approved by the Minnesota Municipal Board.




