ORDINANCE NO. 55, THIRD SERIES

AN ORDINANCE OF THE CITY OF LUVERNE, MINNESOTA
ANNEXING CERTAIN REAL ESTATE TO THE CITY OF LUVERNE

THE CITY OF LUVERNE ORDAINS:

Section 1. That the City is the owner of the following described real estate situated in the County of Rock, State of Minnesota, described as follows, to-wit:

All that part of the Northeast Quarter (NE 1/4) of Section Fifteen (15), Township One Hundred Two (102) North, Range Forty Five (45) West, lying north of the right-of-way of Interstate Highway No. 90 excepting those portions thereof previously annexed into the City limits of the City of Luverne and described as follows:

The East 1385 feet thereof; and, the West 125 feet of the East 1510 feet of the North 1496 feet thereof

and that said property lies immediately adjacent to and contiguous with the boundaries of the City.

Section 2. That the above-described area has or is about to become urban in its nature and character and it is desirable that municipal services including streets, sewers, water and other utilities, fire protection, police protection and other municipal services be extended to said area.

Section 3. That the property situated in the County of Rock, State of Minnesota, described as follows, to-wit:

All that part of the Northeast Quarter (NE 1/4) of Section Fifteen (15), Township One Hundred Two (102) North, Range Forty Five (45) West, lying north of the right-of-way of Interstate Highway No. 90 excepting those portions thereof previously annexed into the City limits of the City of Luverne as described as follows:

The East 1385 feet thereof; and, the West 125 feet of the East 1510 feet of the North 1496 feet thereof

shall be and is hereby annexed to the City of Luverne in accordance with the provisions of Minnesota Statutes 414.033, Subdivision 2.

Section 4. That upon passage and adoption of this ordinance, a copy of the same shall be duly filed with the Minnesota Municipal Board, Luverne Township, Rock County Auditor, and Secretary of State.

Section 5. This ordinance shall be final following its publication, upon the date of its approval by the Minnesota Municipal Board.



M., described as follows: Commencing at the Northwest corner of Lot 5, Gabrielson Addition, thence South along the West line of said Lot 5 and Lot 4 in said Gabrielson Addition to a point 100 feet South of the Northwest corner of said Lot 4, thence West 50 feet, thence North along a line parallel to the West line of said Lots 5 and 4 in Gabrielson Addition 417 feet to a point being on a Westerly projection of the North line of said Lot 5, thence Easterly along said Westerly projection 50 feet to the point of beginning, subject to easements of record; and


Dear Ms. Growe:


