

ORDINANCE ANNEXING TERRITORY TO THE CITY OF MONTEVIDEO

THE CITY OF MONTEVIDEO DOES ORDAIN:

1. The City Council of the City of Montevideo finds as facts:
  - 1.1. The Montevideo Industrial Development Corporation is the owner of the following tract of land in the County of Chippewa and State of Minnesota:

The Southeast Quarter of Southeast Quarter (SE $\frac{1}{4}$ SE $\frac{1}{4}$ ) of Section One (1) and the Northeast Quarter of the Northeast Quarter (NE $\frac{1}{4}$ NE $\frac{1}{4}$ ) of Section Twelve (12) in Township One Hundred Seventeen (117), Range Forty-one (41), lying East of the right of way of Chicago, Milwaukee and St. Paul Railway Company, containing thirty (30) acres more or less.
  - 1.2. That said premises are urban or suburban in character or are about to become so.
  - 1.3. That the said tract of land borders on the City of Montevideo at its westerly boundary.
  - 1.4. The annexation of said premises to the City of Montevideo is in the best interests of the City of Montevideo and of the territory to be annexed.
2. Pursuant to Minnesota Statute § 414.033, Subd. 2, that certain tract of land in the County of Chippewa and State of Minnesota described as follows:

The Southeast Quarter of Southeast Quarter (SE $\frac{1}{4}$ SE $\frac{1}{4}$ ) of Section One (1) and the Northeast Quarter of the Northeast Quarter (NE $\frac{1}{4}$ NE $\frac{1}{4}$ ) of Section Twelve (12) in Township One Hundred

Seventeen (117), Range Forty-one (41), lying East of the right of way of Chicago, Milwaukee and St. Paul Railway Company, containing thirty (30) acres more or less.

is hereby annexed to the City of Montevideo and is incorporated into the corporate limits of the City and shall be zoned as an Industrial Park District.


3. The City Clerk of the City of Montevideo is hereby directed to file a copy of this Ordinance with the State of Minnesota Municipal Board, Sparta Township, the Chippewa County Auditor, and the Secretary of State of the State of Minnesota.

4. This Ordinance shall take effect thirty (30) days after its passage and publication and upon its approval by the Minnesota Municipal Board.
